ASSIGNMENT OF REAL ESTATE PURCHASE AGREEMENT

By Asset Transfer Agreement and Deed dated May 26, 1988 ("Deed"), Burlington Northern Railroad Company ("Railroad") conveyed to Glacier Park Company, a Delaware corporation ("GPC") all its right, title and interest in and to the premises described in that certain Real Estate Purchase Agreement ("Purchase Agreement") dated July 17, 1988, between Railroad as "Seller" and the City of Omaha, Nebraska, as "Buyer". Seller has discovered that said Purchase Agreement should have been entered into by GPC as Seller and not by Railroad as Seller.

Consistent with said Deed, therefore, Burlington Northern Railroad Company does hereby assign and transfer all of its right, title, interest and obligations under the Purchase Agreement to Glacier Park Company, a Delaware corporation ("GPC"), effective on July 17, 1988, the effective date of the Purchase Agreement.

Glacier Park Company does hereby accept assignment of all obligations, right, title and interest in and to the Purchase Agreement.
