Notice is hereby given that Metropolitan Utilities District has, under its construction order procedure, installed a gas main, in the following streets:

On 60th Street between "Q" Street and a point approximately 1000 feet south of "Y" Street,

in Omaha, Douglas County, Nebraska, or adjoining said city, abutting the lots or parcels of land described below:

Lots 16, 17, 44, 45, 46, 47, 64, 65, 66, 71, 72 and 73, South Side Acres

West 88 feet of Tax Lot 4 in the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 7-14-13 east

East 88 feet of the north 1102 feet more or less in the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 12-14-12 east, lying west of 60th Street (County Rd. 28)

West 88 feet of the north 1102 feet more or less in the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 12-14-12 east, lying east of 60th Street (County Rd. 28)

West 88 feet of the south 106 feet more or less of Tax Lot 1 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east, lying east of 60th Street

East 88 feet of the south 108 feet more or less of Tax Lot 1 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east, lying west of 60th Street

East 88 feet of Sub Lot 1 of Tax Lot 2 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east

East 88 feet of Sub Lot 2 of Tax Lot 2 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east

East 88 feet of Sub Lot 3 of Tax Lot 2 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east

East 88 feet of Sub Lot 1 of Tax Lot 3 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east

West 337 feet of the east 425 feet of Sub Lot 1 of Tax Lot 3 in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east

East 88 feet, except street, of the south 1199 feet in the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12-14-12 east

A connection charge of \$ 2.30 per foot will be made as to each of said lots or parcels of land whose owners apply for, and receive, service from such main. This charge is in lieu of an assessment which would have been made if said main had been installed under the statutory procedure for main extensions. The connection charge may be paid in full, or in installments, as provided by the Rules and Regulations of Metropolitan Utilities District.

When the connection charge has been paid in full by the owner of a lot, a receipt will be issued and may be recorded by him. Inquiry may be made of the New "Services" Section of Metropolitan Utilities District as to whether a connection to said main has been made as to any one of the lots or parcels of land hereinabove described, and the amount of the connection charge remaining unpaid, if any.
