MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE is made as of this 5th day of May, 2015, by and between FLATIRON HOTEL, LLC, a Nebraska limited liability company ("Lessor"), having an address of: c/o Dicon Corporation, 11506 Nicholas St., Suite 200, Omaha, NE 68154; and FLATIRON HOTEL MASTER TENANT, LLC, a Nebraska limited liability company (the "Lessee"), having a mailing address of: c/o Dicon Corporation, 11506 Nicholas St., Suite 200, Omaha, NE 68154.

WHEREAS, by that certain Lease dated as of May 5th, 2015 ("Lease"), Lessor leased to Lessee certain space upon the land and improvements located at 1722 St. Mary's Avenue, commonly known as the Flatiron Building, in the City of Omaha, County of Douglas, State of Nebraska and legally described on Exhibit A attached hereto and incorporated herein by this reference (the "Premises"); and

WHEREAS, by this Memorandum, the parties hereto desire to provide notice of such Lease and of certain provisions contained therein.

NOW, THEREFORE, Lessor and Lessee hereby give notice as follows:

- 1. <u>Demise</u>. For and in consideration of the rents reserved and the covenants and conditions more particularly set forth in the Lease, Lessor has leased to Lessee and Lessee has leased from Lessor, and Lessor hereby leases to Lessee and Lessee hereby leases from Lessor, the Premises, together with the right to use all improvements, rights and appurtenances thereto, upon and subject to all of the terms, covenants, conditions and agreements contained in the Lease.
- 2. <u>Term.</u> The initial term of the Lease shall be for the period commencing on May 5th, 2015, and ending on the day immediately preceding the twenty second (22nd) anniversary of the Completion Date (as defined in the Lease), unless extended or sooner terminated as provided in the Lease.
- 3. <u>Binding Effect</u>. The covenants, agreements and conditions set forth herein and contained in the Lease shall run with the land and shall be binding upon and inure to the parties hereto and to their respective heirs, successors and assigns.
- 4. <u>Memorandum Of Lease</u>. In addition to the terms specifically referenced herein, the Lease contains numerous other terms, conditions, and covenants, and notice is hereby given that reference should be made to the Lease directly with respect to the details of such terms, conditions, and covenants. This Memorandum is executed in short form for the convenience of the parties and for the purpose of recording the same, and this Memorandum shall not have the effect of in any way modifying, supplementing, or breaching the Lease or any of its provisions as the same are now or may hereafter be in force and effect. In the event of any inconsistencies between this Memorandum and the Lease, the provisions of the Lease shall prevail.
- 5. <u>Counterparts</u>. This Memorandum may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
