\_\_\_\_\_ heirs and assigns, do hereby grant to Iowa Power and Light Company, its successors or assigns, the right of way to lay, maintain, operate, repair and remove underground pipe for the transportation of gas through and across certain property described below, together with ingress and egress to and from the same, and all the rights and privileges incident and necessary to the enjoyment of this grant.

DESCRIPTION: Easement to consist of a strip of land 10 feet in width lying 5 feet either side of the following described centerline: Commencing at the southwest corner of the northeast quarter of Section 21-72-38; thence north along the west line of said northeast quarter 899.7 feet to the center line of U.S. Highway #34; thence south 88° 48' E 688 feet along the center line of U.S. Highway #34; thence N 01° 12' E 90 feet; thence continuing N 01° 12' E 229 feet to the point of beginning. Thence the center line of said easement is N88° 48' W 155 feet; thence S01° 12' W 62 feet.
