
Fee simple title to g tract of land and all improvements thereon, if any, for highway right of way purposes foculted in the North Half of the Southeast Quarter of Section 15, Township 14 North, Range 12 East of the 6th P.M., Sarpy County, Nebrasia, as influstrated on the attached plat and being more particularly described as follows:

Beginning at the east quarter corner of said Section 15; thence southerly on the East line of the North Haif of the Southeast Quarter of said Section 15 a distance of 1,323.5 feet to the southeast corner of said North Haif of the Southeast Quarter; thence westerly on the South line of said North Haif of the Southeast Quarter a distance of 136.8 feet; thence northerly 90 degrees 06 minutes right a distance of 1,323.5 feet to a point on the North line of said North Haif of the Southeast Quarter; thence easterly 89 degrees 59 minutes right and on said North line a distance of 130.6 feet to the point of beginning, containing 4.06 acres, more or less, which includes 1.54 acres, more or less, previously occupied as a public highway, the remaining 2.52 acres, more or less, being the additional acreage to be secured in this action.

There will be no ingress or egress from the above described-tract of land onto the remainder of said North Haif of the Southeast Quarter, except over one field entrance, not to exceed 20 feet in width, to provide for the movement of farming implements and crops, so long as it is used consistent with mormal farming operations of the owner, the centerline of which is to be located 117.9 feet southerly from the North line of said North Haif of the Southeast Quarter, as measured along the centerline of the highway.

All mineral rights in the above described tract shall be retained and reserved to the Condemnee, her helps, successors or assigns. The Condemnee, her helps, successors or assigns shall have no right to use or enter the surface of the above described tract for any purpose concerning the reserved mineral rights; nor shall the Condemnee, her helps, successors or assigns in extracting such minerals, damage or in any way impair the use of the above described tract.
