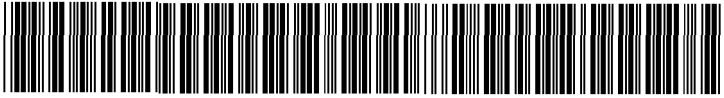

The Lessor is: The County of Douglas, in the State of Nebraska


The Lessee is: Phillips Realty, LLC, a Nebraska limited liability company

The term of the Lease commenced December 1, 2002 and ends December 1, 2018, unless extended by Lessee's exercise of renewal options as provided in said Lease.



Under the Lease, the Lessee has the option to purchase said real estate.



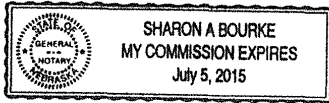

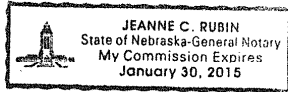
