AGREEMENT

Walter E. Hoyle & wife and Natural Gas Pipeline Co. of America
AGREEMENT CONCERNING LOCATION OF PIPELINE N-33

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned Walter E. Hoyle and Bessie B. Hoyle, his wife, herein called grantors, the former being the present owner of the following real estate in Gage County Nebraska.

SE 1/4 of Section 16 and Part of NW 1/4 SEC 15 T 4 N- R 6 E

upon which real estate Natural Gas Pipeline Company of America (formerly Continental Construction Corporation), herein called Grantee, has constructed and now operates a pipeline for the transportation of natural gas pursuant to the rights and privileges granted and vested in it by a certain right-of-way contract dated May 14, 1930 executed by the then owners of said land, covering said real estate, and of record in Book 0 at Page 504 0 at page 503 of the records of said County and State, said contract providing for the construction and operation of said pipeline and also providing for the construction of additional pipeline/s on said land without specifying the location of additional pipeline/s, The Grantee wishing to locate a second line at substantial distance from the first and having requested that Grantors consent that such second line may be located as herein indicated,

For valuable consideration to them paid by Grantee, receipt of which is acknowledged, now agree with Grantee and consent that Grantee may construct a second pipeline provided for in said contract at the following location on said real estate:

Across a strip of land 1000-feet in width which shall be parallel to and immediately northwest of the present 24-inch pipeline.

and Grantors agree that said right-of-way contract is modified and made more certain to the extent of so designating the location of said second pipeline.
