An ordinance approving the plat of Burnham Addition, an addition to the City of Beatrice, Gage County, Nebraska as executed by the owners thereof, certified by the surveyor and engineer of said subdivision, and approved by the Planning and Zoning Commission of the City of Beatrice, Nebraska; to repeal conflicting ordinances; and to provide for publication in pamphlet form and an effective date of this ordinance.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BEATRICE, NEBRASKA:

SECTION 1. That the plat of Burnham Addition, an addition to the City of Beatrice, Gage County, Nebraska, as executed by the owner thereof, Beatrice National Bank and Trust Company, Trustee, certified by William L. 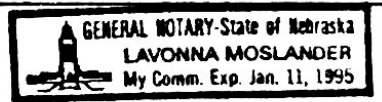
