**SURVEYOR'S CERTIFICATE**

I, the undersigned Registered Land Surveyor, hereby certify that:

1. I shall accurately survey, and I shall install permanent iron pins at the corners of all blocks, streets, angle points and at the end of all curves upon the completion of the grading, and that a bond has been furnished the City of Omaha, Nebraska in order to insure the placing of permanent monuments and iron pins as shown on the plat of Omaha Industrial Foundation - District No. 3.
2. That said Omaha Industrial Foundation - District No. 3 is a plat of a tract of land located in the North half of Section 1, Township 14 North, Range 11 East, and in the South half of Section 36, Township 15 North, Range 11 East of the Sixth Principal Meridian in Douglas County, Nebraska, the boundaries of which are described as follows:

**Parcel located southwesterly of U. S. Highway 275**

Commencing at the east quarter corner of Section 1, T 14 N, R 11 E; thence N. 88° 55' 51" W., along the south line of the northeast quarter of said Sec. 1, 694.14 feet to a point; thence N. 1° 04' 09" E. 33.00 feet to the POINT OF BEGINNING, which is the point of intersection of the north right-of-way line of "L" Street and the southwesterly right-of-way line of U. S. Highway 275; thence N. 44° 45' 51" W., along the southwesterly right-of-way line of U. S. Highway 275, 255.79 feet to a point; thence continuing along said southwesterly right-of-way line 957.56 feet along the arc of a circular curve to the right which has a radius of 2024.86 feet and a chord length and bearing of 948.66 feet and N. 57° 26' 43" W., respectively; thence N. 43° 53' 52" W., continuing along said southwesterly right-of-way line, 1390.97 feet, on a line tangent to the last described arc, to a point on the east line of the northwest quarter of said Sec. 1; thence N. 43° 53' 52" W., continuing along said southwesterly right-of-way line, 1232.28 feet to a point on the north line of the northwest quarter of said Sec. 1; thence S. 89° 42' 24" W., along the north line of the northwest quarter of said Sec. 1, 863.42 feet to a point on the northeasterly right-of-way line of the Union Pacific Railroad; thence S. 49° 00' 44" E., along said northeasterly right-of-way line, 168.55 feet to a point of curvature; thence continuing along said northeasterly right-of-way line 825.01 feet along the arc of a circular curve to the right which is tangent to the last described course and which has a radius of 5779.65 feet and a chord length and bearing of 824.31 feet and S. 44° 55' 22" E. respectively; thence S. 40° 50' 01" E., continuing along said northeasterly right-of-way line on a line tangent to the last described arc, 1529.36 feet to a point on the east line of the northwest quarter of said Sec. 1; thence S. 40° 50' 01" E., continuing along said northeasterly right-of-way line, 927.09 feet to a point on the north right-of-way line of "L" Street; thence S. 88° 55' 51" E., along the north right-of-way line of "L" Street, which is parallel to and 33.00 feet north of the south line of the northeast quarter of said Sec. 1, 1346.75 feet to the point of beginning containing 54.87 acres more or less and subject to sewer easements as shown on the plat.

**Parcel located northeasterly of U. S. Highway 275**

Commencing at the northeast corner of Section 1, T 14 N, R 11 E, thence S. 89° 42' 14" W., along the north line of the northeast quarter of said Sec. 1, 110.00 feet to the POINT OF BEGINNING, which point is on the west right-of-way line of 132 nd Street; thence N. 0° 00' 19" E., along said west right-of-way line, which is parallel to and 110.00 feet west of the east line of the southeast quarter of Section 36, T 15 N, R 11 E, 568.57 feet to a point on the south right-of-way line of the Union Pacific Railroad; thence S. 89° 51' 06" W., along said south right-of-way line, 1544.24 feet to a point of curvature; thence continuing along said south right-of-way line 985.82 feet along the arc of a circular curve to the right which is tangent to the last described course and which has a radius of 3877.77 feet and a chord length and bearing of 983.17 feet and N. 82° 50' 25" W. respectively, to a point on the west line of the southeast quarter of said Sec. 36; thence S. 0° 02' 42" E., along the west line of the southeast quarter of said Sec. 36, 25.92 feet to a point; thence along the southwesterly right-of-way line of the Union Pacific Railroad 1453.28 feet, along the arc of a circular curve to the right which has a radius of 3902.77 feet and a chord length and bearing of 1444.90 feet and N. 64° 56' 46" W. respectively, to a point; thence N. 54° 18' 11" W., continuing along said southwesterly right-of-way line on a line tangent to the last described arc, 1458.36 feet to a point; thence S. 29° 11' 38" E. 372.70 feet to a point on the northeasterly right-of-way line of U. S. Highway 275; thence S. 43° 53' 52" E., along said northeasterly right-of-way line, 2518.18 feet to a point on the south line of the southwest quarter of said Sec. 36; thence S. 43° 53' 52" E., continuing along said northeasterly right-of-way line, 808.14 feet to a point on the west line of the northeast quarter of said Sec. 1; thence S. 43° 53' 52" E., continuing along said northeasterly right-of-way line, 1610.33 feet to a point of curvature, thence continuing along said northeasterly right-of-way line 1352.91 feet, along the arc of a circular curve to the left, which is tangent to the last described course, and which has a radius of 1809.86 feet and a chord length a bearing of 1321.63 feet and S. 65° 18' 46" E. respectively; thence S. 86° 43' 40" E., continuing along said northeasterly right-of-way line, 242.79 feet, on a line tangent to the last described arc, to a point on the west right-of-way line of 132 nd Street, thence due north, along said west right-of-way line, which is parallel to and 75.00 feet west of the east line of the northeast quarter of said Sec. 1, 1229.01 feet, thence N. 89° 59' 58" W., continuing along said west right-of-way line, 35.00 feet; thence due north, continuing along said west right-of-way line, which is parallel to and 110.00 feet west of the east line of the northeast quarter of said Sec. 1, 1095.43 feet to the point of beginning containing 168.27 acres more or less and subject to sewer easements as shown on the plat.

In the above descriptions the east line of the northeast quarter of Section 1, T 14 N, R 11 E, (centerline of 132 nd Street) is assumed to have a bearing of due north and south.
