KNOW ALL MEN BY THESE PRESENTS, that OMAHA PUBLIC POWER DISTRICT, a public corporation, for and in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby release and disclaim any rights it may have attained by virtue of the Plat and Dedication for Elk Hills Addition, an addition as surveyed, platted and recorded in Douglas County, Nebraska, over, upon, along and above the following described property:

Releasing a strip of land Ten feet (10') in width, being Five feet (5') each side of and abutting the common side lot line of Lots One (1) and Two (2), Excepting the east Eight feet (8') and west Five feet (5') of these Lots in Elk Hills.

And releasing a strip of land Ten feet (10') in width, being Five feet (5') each side of and abutting the common side lot line of Lots Two (2) and Three (3), Excepting the east Eight feet (8') and west Five feet (5') of these Lots in Elk Hills.

And releasing a strip of land Ten feet (10') in width, being Five feet (5') each side of and abutting the common side lot line of Lots Four (4) and Five (5), Excepting the west Eight feet (8') and east Five feet (5') of these Lots in Elk Hills.
