AN ORDINANCE OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA, PROVIDING FOR THE VACATING OF A PUBLIC WAY IN SAID CITY; PROVIDING FOR THE FINDING THAT NO SPECIAL DAMAGES WILL BE INCURRED BY ANY OWNERS OF PROPERTY ABUTTING SAID VACATED PUBLIC WAY AS THE RESULT OF SUCH VACATION; PROVIDING FOR THE REPEAL OF ALL ORDINANCES OR PARTS THEREOF IN CONFLICT HEREWITH; AND PROVIDING FOR THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WILBER, SALINE COUNTY, NEBRASKA:

SECTION 1. That the following described public way located within the City of Wilber, Saline County, Nebraska, is hereby vacated as such a public way, to-wit:

The alley running north and south between Lots Numbered Five Hundred Twenty-Two (522), Five Hundred Twenty-Three (523), Five Hundred Twenty-Eight (528) and Five Hundred Twenty-Nine (529), Inclusive, Original City of Wilber, Saline County, Nebraska.

SECTION 2. That the vacation of the public way as set forth in SECTION 1. of this Ordinance is expedient for the public good and is in the best interests of the City of Wilber, Saline County, Nebraska.

SECTION 3. That the City of Wilber, Saline County, Nebraska, shall retain an easement over the public way vacated by this Ordinance for the purpose of maintaining all utilities which may now or hereafter be located therein or thereon.

SECTION 4. That one-half (½) of the public way vacated by this Ordinance shall revert to owners of real estate adjacent to said vacated public way.

SECTION 5. That no special damages were incurred by any owners of real estate abutting the public way vacated by this Ordinance as the result of such vacation.

SECTION 6. That the Clerk of the City of Wilber, Saline County, Nebraska, shall forthwith certify to the Clerk of Saline County, Nebraska, a true copy hereof.

SECTION 7. That this Ordinance shall take effect and be in full force from and after its' passage, adoption, and publication as required by law.
