MEMORANDUM OF WIND FARM OPTION AGREEMENT

This is a Memorandum ("Memorandum") of a Wind Farm Option Agreement ("Option Agreement") signed at the same time as this Memorandum between Annette & David Sweeney, wife and husband, whose address for purposes of this Memorandum is 21547 Co Hwy S27, Alden, IA 50006, its successors and assigns ("Owner"), as grantor, and American Heartland Development, LLC a Delaware limited liability company, its successors and assigns ("American"), as grantee, pertaining to Owner's Property legally described on the attached copy of Exhibit A to the Option Agreement, a copy of which is attached to this Memorandum as Exhibit A.

- 1. <u>Easements</u>. The Option Agreement is an option with respect to the Owner's Property for a Wind Farm Easement Agreement ("<u>Easement Agreement</u>") granted by Owner in favor of American including any or all of the following easements: turbine site, access, collection facilities, overhang, construction, wind non-obstruction, noise, shadow, met tower and other easements.
- 2. Exercise of Options. Exercise of the Option Agreement as to a portion of Owner's Property and/or exercise to obtain a overhang, construction, wind non-obstruction, sound, and light and shadow easements as to all or a portion of Owner's Property shall not terminate this Option Agreement.
- 3. <u>Term of Option</u>. The term of the Option Agreement ends five (5) years from the date American signs this Memorandum, provided American may extend the Option Agreement for one (1) additional two (2) year extension period, as more specifically provided in the Option Agreement.
- 4. <u>Assignment.</u> Owner may freely sell, mortgage, or lease the Owner's Property to others; <u>provided</u>, that any transfer by Owner will be subject to the Option Agreement.
