Aparcel of land situated in the Northeast Quarter of the Southeast Quarter (NE1/4 SE1/4) of Section 34, Township 16 North, Range 11 East of the 6th P. M., in Douglas County, Nebraska, said parcel described as follows:

Commencing at the East Quarter Corner of said Section 34; thence along the Northerly line of said southeast Quarter, South 87°37'15" West, 45.00 feet, to the Point of Beginning; thence continuing along said Northerly line, South 87°37'15" West, 285.00 feet; thence parallel with the Easterly line of said Southeast Quarter, South 02°47'56" East, 454.50 feet; thence parallel with the Northerly line of said Southeast Quarter, North 87°37'15" East, 285.00 feet, to a point on the Westerly right-of-way line of 156th Street, as now established; thence along said Westerly
