

In consideration of the dollar and other valuable consideration, the undersigned, being the owners of the property described herein, hereby grants to the City of Fremont, Nebraska, and any public or private utility company having a franchise from the City of Fremont, an easement over the following described real estate, located in County Club Resubdivision to Fremont, Nebraska.

- Block 1: 5-feet on either side of common line between Lots 2 and 3 and 5 and 6; 7 and 8
- Block 2: 5-feet on either side of the common line between Lots 4 and 5; 8 and 9; 10 and 11; 12 and 13 and 14 and 15
- Block 3: 5-feet on either side of the common line between Lots 1 and 2; 8 and 9; 10 and 11; 11 and 12; 13 and 14; 13 and 15; 16 and 17; 15 and 16; 20 and 21
- Block 4: The east 10-feet of Block 4; the south 5-feet of Lot 3 and the north 5-feet of Lot 4
- Block 5: 5-feet on either side of the common line between Lots 2 and 3; 5 and 6 and 9; 11 and 12; 13 and 14
- Block 6: 5-feet on either side of the common line between Lots 2 and 3; 4 and 5; 6 and 7; 5 and 6; 8 and 9

- Block 8: 5-feet on either side of the common line between Lots 1 and 2; 3 and 4, for the sole purpose of constructing and maintaining utility lines

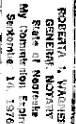
