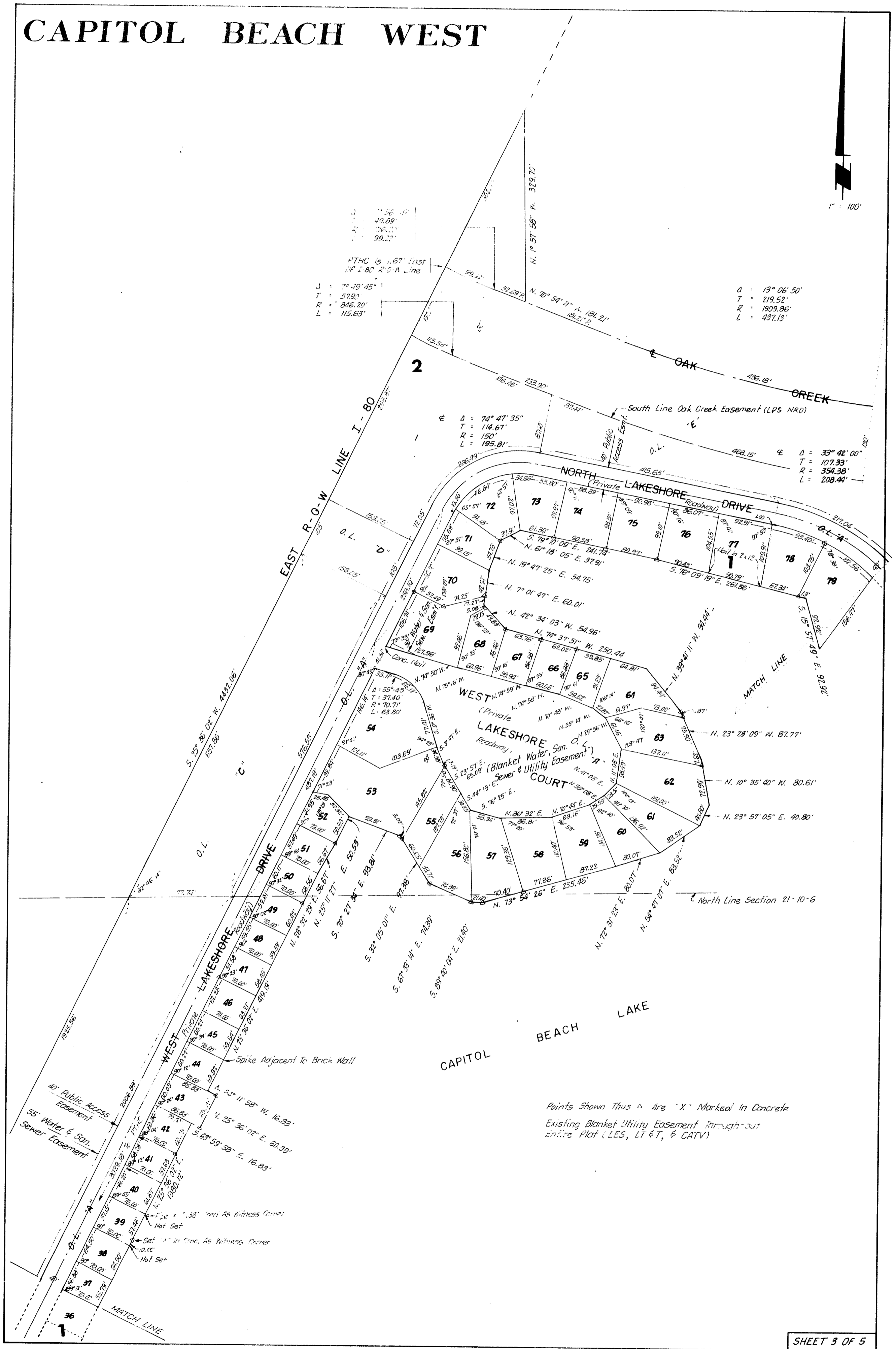

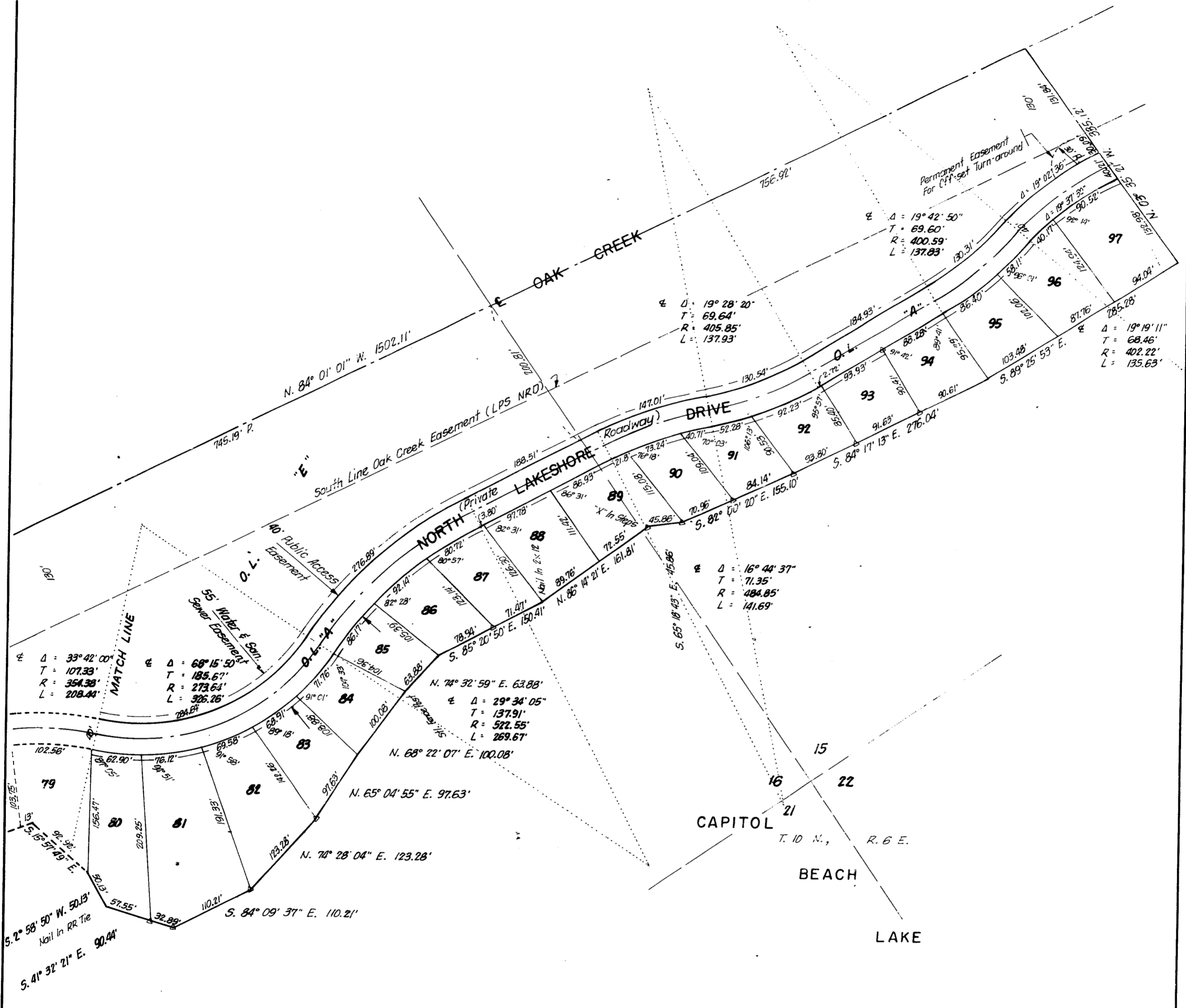

Permanent monuments (as indicated on the plat) have been placed at all street intersections, points of curvature, centerline points of tangency and at all other points required by the City of Lincoln Land Subdivision Ordinance, Title 26 of the Lincoln Municipal Code.

All dimensions are chord measurements, unless shown otherwise, and are in feet and decimals of a foot.

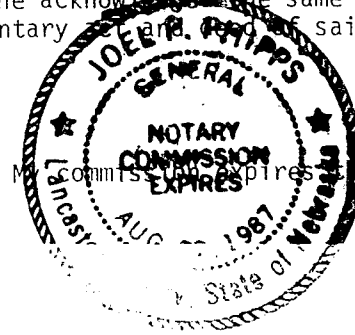

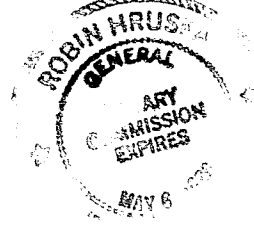
