ORDINANCE NO. 4322.

An Ordinance amending Section 1 of Ordinance No. 3367 passed April 2, 1934, vacating the alley in Block 12, Capitol Hill Addition to the City of Lincoln, Nebraska; providing for the filing of a copy of this ordinance with the Register of Deeds of Lancaster County, Nebraska; and repealing Section 1 of Ordinance No. 3367, passed April 2, 1934, as hitherto existing.

BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

Section 1. That Section 1 of Ordinance No. 3367, passed April 2, 1934, be and it hereby is amended to read as follows:

"Section 1. That the alley in Block Twelve (12), Capitol Hill Addition to the City of Lincoln, Nebraska, located between 27th and 28th Streets and between Laurel and Sherman Streets, be and the same is vacated upon the following conditions:

"That the City of Lincoln reserves the right of way through and in said alley so vacated for all sewers and water pipes, all electric wires, electric pole lines, all telephone and telegraph lines: telephone and telegraph wires, and all underground conduits now located therein, or which the City of Lincoln may hereafter direct to be located therein either for its own use and behalf or for the use and behalf of holders of franchises heretofore granted or hereafter granted by the said City of Lincoln, and reserves the right of way to enter said alley so vacated for itself and for the holders of said franchises at any time for the construction, maintenance and repair of such sewers, water pipes, electric wires, electric pole lines, telephone and telegraph lines, telephone and telegraph poles, and underground conduits."

Section 2. That the City Clerk shall, immediately upon the taking effect of this ordinance, file with the Register of Deeds of Lancaster County, Nebraska, a certified copy of this ordinance.

Section 3. That Section 1 of Ordinance No. 3367, passed April 2, 1934, as hitherto existing, be and it hereby is repealed.

Section 4. This ordinance shall take effect and be in force from and after its passage and publication according to law.
