## EXHIBIT "E" MEMORANDUM OF REDEVELOPMENT AGREEMENT

This Memorandum of Redevelopment Agreement ("Memorandum") is made this  $17^{+0}$  day of December, 2019 by and between The Community Redevelopment Authority of the City of Hastings, Nebraska, ("CRA"), and Brant Rentals, LLC, a limited liability company ("Redeveloper").

1. **Redevelopment Agreement**. The CRA and Redeveloper have entered into that certain Redevelopment Agreement dated as of this even date, describing certain public improvements being made by the CRA in the Redevelopment Area and certain private improvements being made to real property owned by Redeveloper legally described as:

LOTS EIGHT (8) AND NINE (9) BLOCK TWENTY-TWO (22), IN THE ORIGINAL TOWN, NOW THE CITY OF HASTINGS, ADAMS COUNTY, NEBRASKA ACCORDING TO THE RECORDED PLAT THEREOF.

- 2. **Tax Increment Financing**. The Redevelopment Agreement provides for the capture of the Tax Increment, as defined therein, by the CRA of the private improvements to be made by the Redeveloper for a period not to exceed fifteen (15) years after the Project Effective Date defined in the Redevelopment Agreement. The Tax Increment so captured by the CRA shall be used to make the public improvements as described in the Redevelopment Agreement.
- 3. **Remaining Terms**. The rest and remaining terms of the Redevelopment Agreement are hereby incorporated into this Memorandum as if they were set forth in full. A full and correct copy of the Redevelopment Agreement may be inspected at the office of the City Clerk of Hastings, Nebraska.
