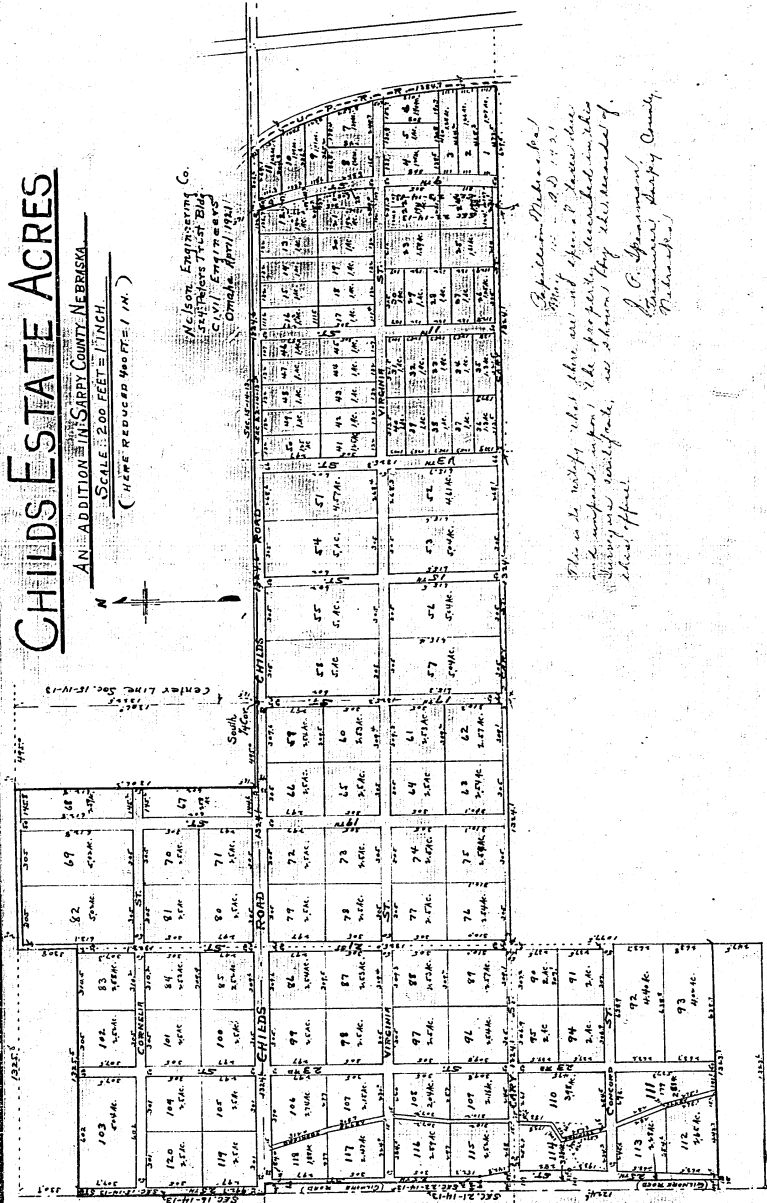

Sarpy County, Nebraska; thence West along the South line of said Section 15; 495.0 ft. thence North and parallel to the North and south center line of said section 15, 1322.8 ft. to the North line of the Southeast 1/4 of the Southwest 1/4 of said Section 15, thence West along said North line 830.8 ft; to the Northwest corner of the Southeast 1/4 of the Southwest 1/4 of said Section 15; thence south along the west line of the said Southeast 1/4 of the Southwest 1/4 330.8 ft; thence west 1325.5 ft. to a point on the west line of said Section 15, 992.7 ft. North of the Southwest corner of said Section 15, thence South along the West line of said section 15; 992.7 ft. to the northwest corner of Section 22-14-13; thence East along the North line of said Section 22, 49.5 ft. thence South and parallel to the West line of said Section 22, 2401.7 ft. to a point 49.5 ft East and 247.5 ft. North of West 1/4 corner of said Section 22; thence East and parallel to the East and West center line of said Section 22, 1323.7 ft. to the North and South center line of the Northwest 1/4 of said Section 22, thence North along said center line 1077.5 ft. to the East and west center line of the North 1/2 of said Section 22; thence East along said center line 3972.3 ft. to the Southeast corner of the Northeast 1/4 of the Northeast 1/4 of said Section 22; thence East along the East and West center line of the Northwest 1/4 of Section 23-14-13, 629.5 ft. to the Westerly Right of way line of the Union Pacific Railroad; thence Northwesterly along said Right of way line, 1324.7 ft. to the North line of said Section 23; thence West along the North line of said Section 23, 306.6 ft. to the Northeast corner of Section 22-14-13; thence West along the North line of said Section 22, 2549.2 ft. to the place of beginning.
