

## RECEIPT.

The Prospect Hill Cemetery Assn.

Omaha Nebr. September 9th, 1910  
Received of William B. Wood the sum of One hundred &  
twenty five (\$125.00) Dollars to be by this Association  
paid over to Henry W. Yates Trustee, or to his succe-  
sor as such Trustee with power to invest and reinvest  
the same, the net annual income to be paid to this

Association by such trustee; Provided however that said sum may be kept and invested by said  
Trustee with other moneys advanced by other lot owners for similar purposes and in that event  
at the end of each year a pro rata part of the net yearly income of the said aggregate fund  
shall be paid to this Association as the net annual income from said sum of One hundred &  
Twenty five (\$125.00) Dollars.

In lieu of annual dues, one per cent of said sum of One hundred & Twenty five (\$125.00)  
Dollars shall be retained by this Association out of the net annual income so paid to it by  
said Trustee and shall be expended for the general care of Prospect Hill Cemetery; and this  
Association agrees perpetually to apply the balance of said net annual income so paid to it  
by said Trustee for the care of Lot number East half Lot 174, First Addition in said Cemetery  
all of the improvements thereon.

Any portion of said income that shall not be needed for the above purposes this  
Association is authorized to expend in such manner as in the judgment of its Board of Trustees  
or its successor or successors shall most conduce to the improvement and embellishment of  
said lot and the approaches thereto.
