ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS: That Nebraska Public Power District, a public corporation and political subdivision of the State of Nebraska, hereinafter called District, in consideration of the performance of the terms and conditions of an Agreement for Sale of Electric Facilities by Nebraska Public Power District to Omaha Public Power District, and the benefits to accrue to both parties set forth therein, the receipt whereof is hereby acknowledged, does hereby sell, assign, and transfer unto Omaha Public Power District, a public corporation and political subdivision of the State of Nebraska, and its successors and assigns, hereinafter called OPPD, all of the right, title and interest in and to the District's easements, together with all of the rights and privileges pertaining thereto, located within the area described as follows:

The Easements for approximately 4.0 miles of 115 KV transmission line, said easements which begin at Structure # 657 located in the W1/2SW1/4 of Section 21, T14N, R13E in Sarpy County, Nebraska, and extend south and east through portions of Sections 21, 28, 27, 26, 25, 36 all in T14N, R13E ending at Structure # 29 west of the Kramer Substation. Specific interests in said easements are more fully described in the attached Exhibit "B". Said transmission line route is outlined on attached Exhibit "A".

To have and to hold said easement interests unto OPPD, its successors and assigns forever.

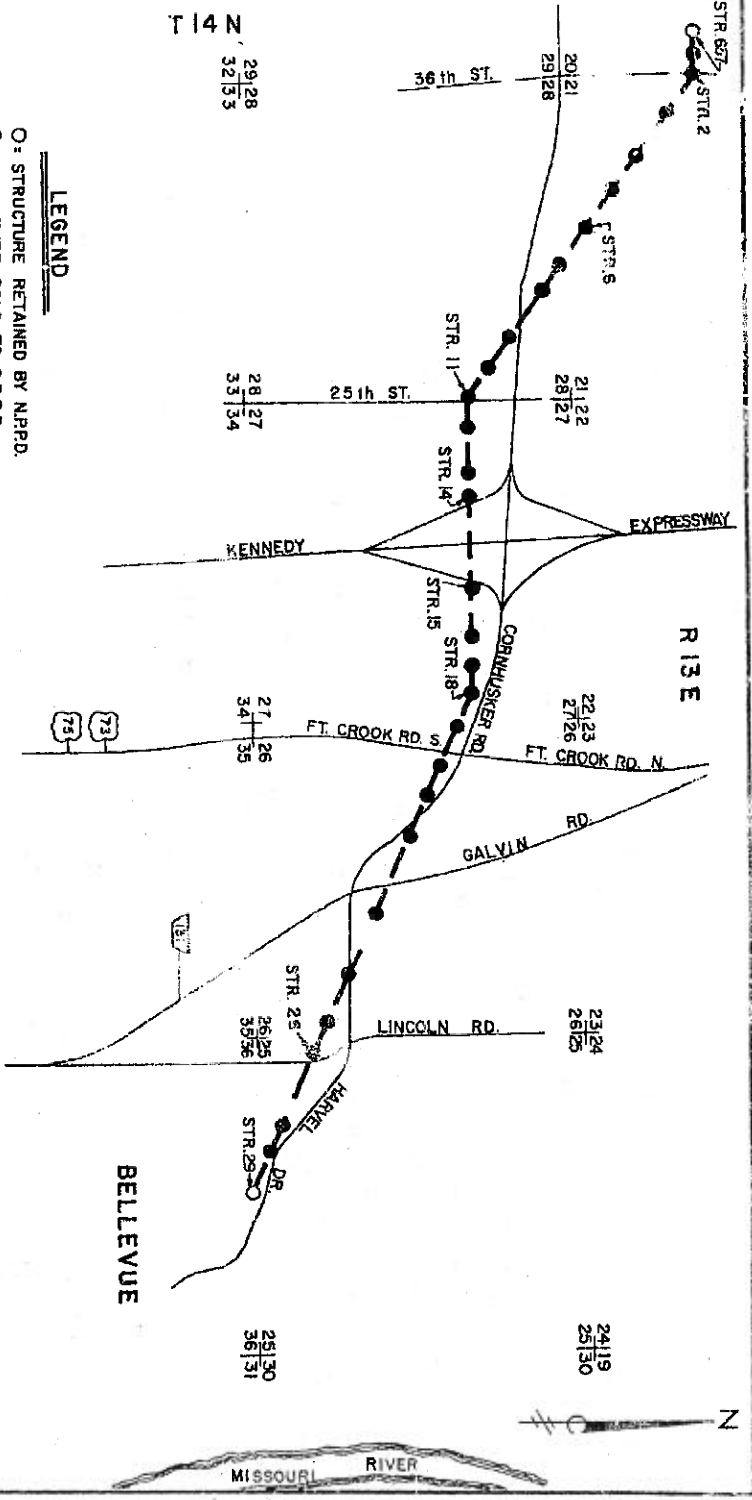
