

## AMENDMENT TO RESTATED MASTER DEED FOR CRYER CREST TOWNHOMES ASSOCIATION, INC. A SUBDIVSION IN DOUGLAS COUNTY, NEBRASKA

This Amendment to Restated Master Deed is made on the date hereinafter set forth by Owners representing 75% of the Owners of Cryer Crest Townhomes Association, Inc.

## PRELIMINARY STATEMENT

By Restated Master Deed for Cryer Crest Townhomes Association, Inc., a Subdivision in Douglas County, Nebraska, dated August 7, 2001, and recorded in Book 1393, Page 409 of the Miscellaneous Records of the Register of Deeds of Douglas County, Nebraska (herein referred to as the "Master Deed"), Declarant subjected the following described lots/units to restrictions, covenants, conditions and easements:

## Units 1-27, inclusive, Cryer Crest Townhomes Condominium Property Regime, Omaha, Douglas County, Nebraska.

The undersigned Owners do hereby substitute amend and restate the Restated Master Deed in the following particulars:

- 1. The Owners do hereby restate and substitute for Section 8, paragraph d, the following:
  - d. Each unit shall be used and occupied only by one family, its servants and guests as a residence and for no other purpose. No unit may be subdivided into a smaller unit nor any portion thereof rented, sold or transferred. No unit may be combined in whole or in part with other units or rented, sold or transferred as such.
- 2. The Owners do hereby restate and substitute for Section 8, paragraph f, the following:
  - f. No unit owner may sell his unit or any interest therein without giving prior notice to the Association. This provision shall not affect transfer by death, but any person inheriting such unit shall be subject to the restrictions herein on subsequent transfer.

An owner intending to make a sale of his unit shall give the Association written notice thereof together with the proposed price and terms of such sale, also providing, if engaged, the name of the real estate listing agent, his/her company name and phone number. In the event of sale, the Treasurer of the Board shall provide to the listing agent a copy of the Master Deed and Bylaws, an authorization form for electronic deposit of monthly assessment by the new owner, a copy of important rules found in the Bylaws, and any other such Association documents as required by law and as would apply to the ownership of a townhome in Cryer Crest, to be presented to the new owner at time of transfer of the deed or earlier if required.

- 3. The Owners do hereby restate and substitute for Section 8, paragraph g, the following.
  - g. The condominium regime and all units therein are intended for the sole occupancy of the owners thereof as provided in "8d" and no unit or any part thereof may be leased, subleased or rented for any period of time. Each unit which is rented to a tenant at the time of execution of this amendment may continue to be rented until the current lessee or tenant moves out. Any unit which is not currently rented to a tenant, whether or not currently owner-occupied, may not be rented to a tenant regardless of whether that agreement is an oral or written lease agreement.

Amendment shall become effective on the date recorded and filed with the Register of Deeds of Douglas County, Nebraska.
