### FIRST AMENDMENT TO MASTER DEED

#### **CREATING**

#### CRYER CREST TOWNHOMES CONDOMINIUM PROPERTY REGIME

The undersigned are the owners of more than 75 per cent of both the number and of the basic value of the units in the foregoing named condominium created by Master Deed, recorded in Deed Book 1467, Page 463, in the Register of Deeds of Douglas County, Nebraska and hereby partially amend said Master Deed and the condominium plans attached thereto, as follows:

- 1) Subparagraph (f) of Paragraph 7 of said Master Deed is wholly amended to read as follows:
  - No unit owner may sell or lease his unit or any interest therein without the prior approval of the Association. This provision shall not affect transfer by death but any person inheriting such unit shall be subject to those restrictions on subsequent transfer. An owner intending to make a sale or lease of his unit shall give the Association written notice thereof together with the price and terms of such sale or lease. Within fifteen (15) days after receipt of such notice, the Association shall by written notice to the owner either approve such purchase or lease or elect to either purchase the property for said price and terms or lease the property on the terms and for the price of the Association. This provision shall not the property on the terms and for the price contained in said lease. If the Association elects to purchase or lease, closing shall be within thirty days thereafter. Failure of the Association to act within the first fifteen day period shall be deemed an approval of the sale or lease. The above provisions regarding approval of transfers shall not apply to acquisition of ownership through foreclosure of a mortgage upon a unit."

- Said condominium property regime hereby wholly adopts the amendments to the Nebraska Condominium Property Act enacted by Legislative Bill 730 of 1974 Unicameral Legislature (83rd Legislature - Second Session).
- 3) Except as above provided, said original Master Deed remains unchanged and in full force and effect.


