REPORT OF APPRAISERS

Come now the undersigned appraisers duly appointed in this matter to assess the damages that have been sustained by the owners and other persons interested in the premises hereinafter described, and we do hereby respectfully report that after subscribing the oath at the time and place appointed by the Court and as required by law we proceeded in a body to view the lands in the respective parcels involved herein and there fully informed ourselves in said matter and heard the evidence as offered by the interested parties.

We took into consideration that the condemner proposes to construct immediately a 161,000 volt double circuit steel tower transmission line for the transmission of electricity, together with the necessary footings, wires, and other fixtures and appliances, over, upon, along and above the property hereinafter described, together with the right, privilege and authority to enter upon and pass over such property for the purpose of constructing, repairing, operating and maintaining said line and equipment upon such property. The location of the lines and structures on the respective parcels hereinafter described are shown on the plats in Exhibit A attached hereto and made a part hereof.

That said transmission line is generally described as a double circuit steel tower transmission line with provision for eight conductors to be supported on four steel crossarms, attached to a steel tower, four conductors on each side, one above the other. Five will be installed at this time; the remaining three conductors will be added at some future date. The dimensions of said steel towers vary, being approximately five to six feet square at the top, approximately seventeen to twenty-eight feet square at the bottom, and approximately ninety-seven to one hundred thirty-two feet tall.

The majority of the towers will be approximately eighteen feet square at the bottom and approximately one hundred two feet tall. The minimum clearance of the lowest conductors at the bottom cross-arm will be approximately forty-five feet and the center of the span will be approximately twenty-nine feet at 120° Fahrenheit.

A perpetual easement is condemned for a right of way fifty feet on each side of a centerline, or one hundred feet in width, with the right to trim or fell trees and remove obstructions within fifty feet of the centerline of said right of way which would be a hazard to said transmission line, together with all rights and privileges incident to the use and enjoyment of said easement.

Being fully advised in the premises, we do hereby find, fix and assess the damages sustained by reason of the appropriation of a permanent easement and right of way for the construction, operation and maintenance of petitioner's electric transmission line on and across the parcels of land described in the petition filed herein and in the plats of said lands attached hereto, made a part hereof and incorporated herein and marked Exhibit A for reference.

The description of the parcels, the descriptions of the easements and our awards of damages to the respective owners or other persons interested therein, are as follows:

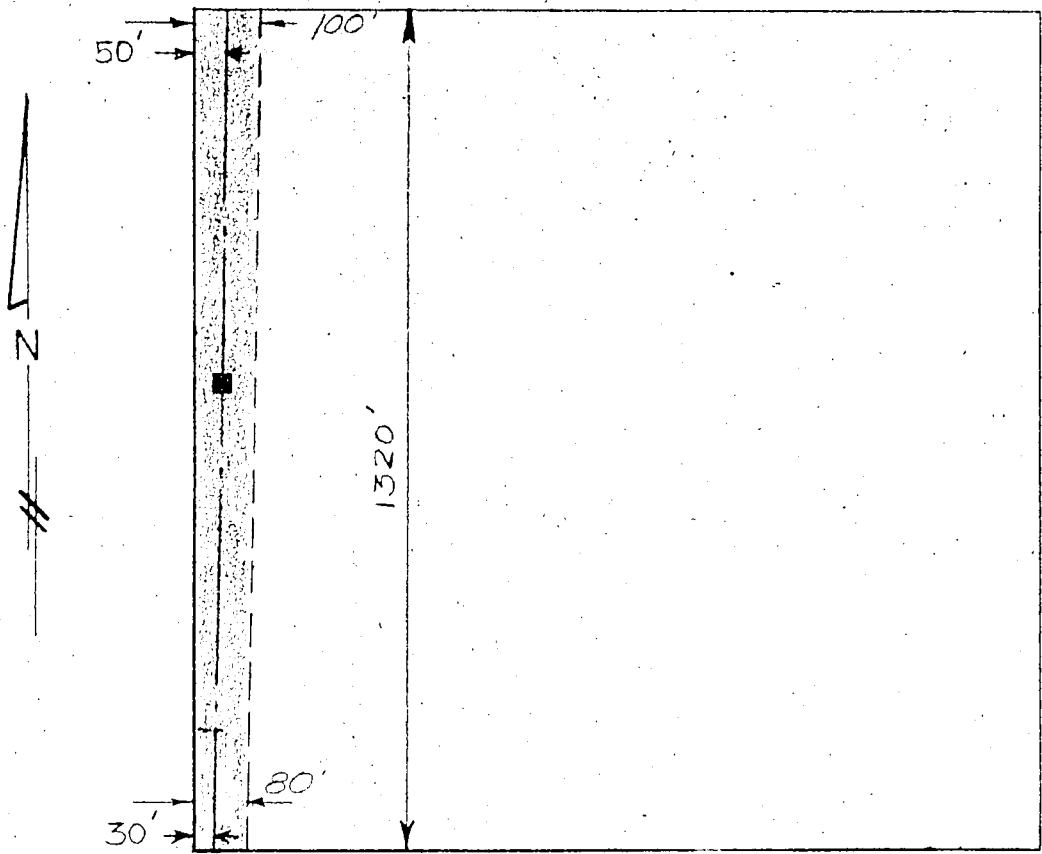

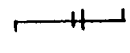

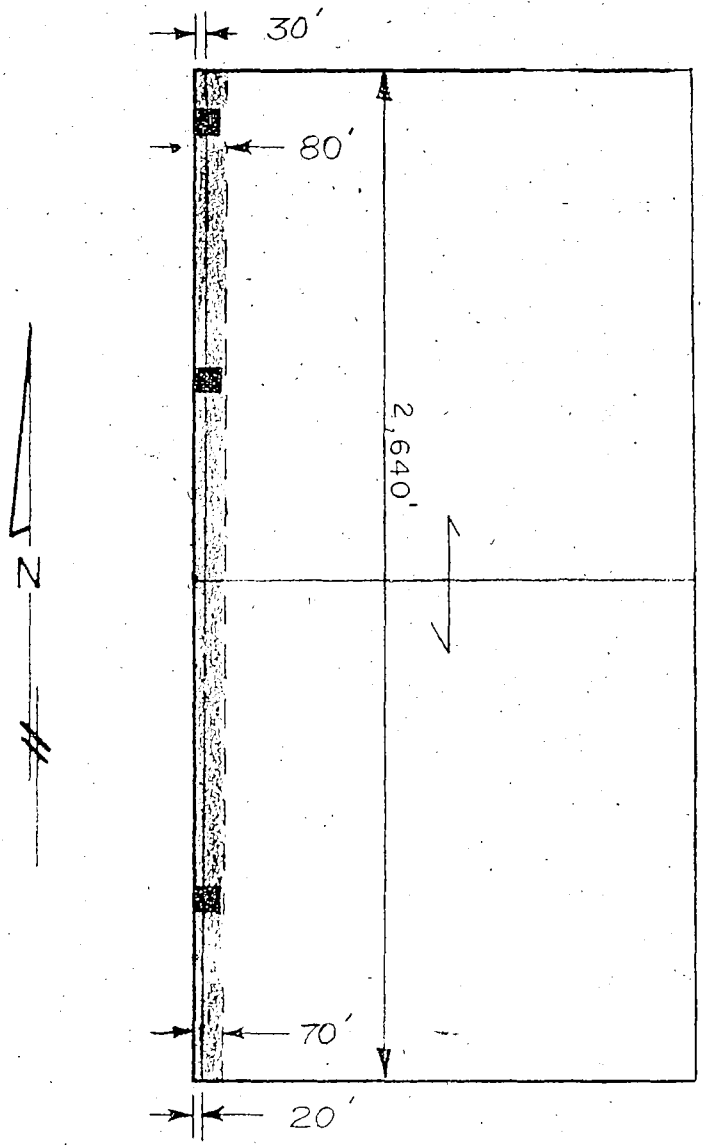

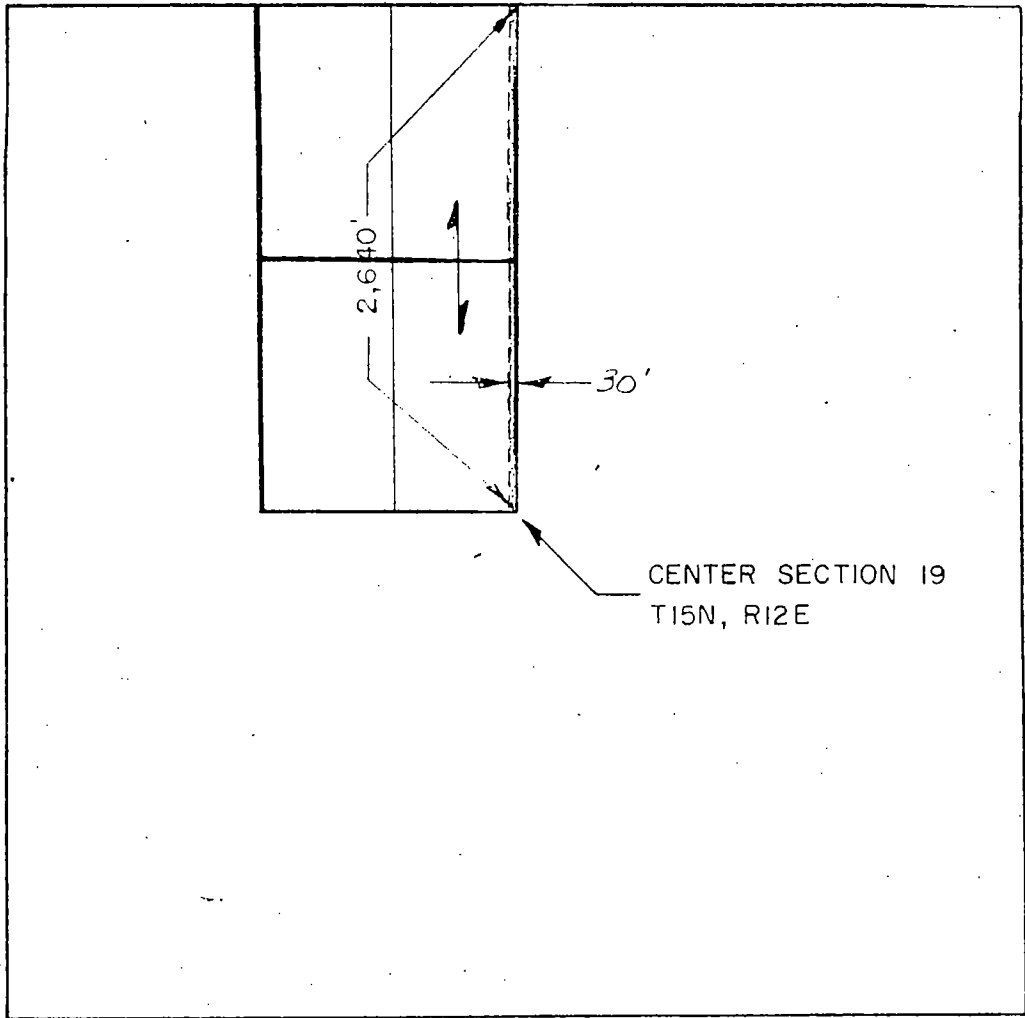

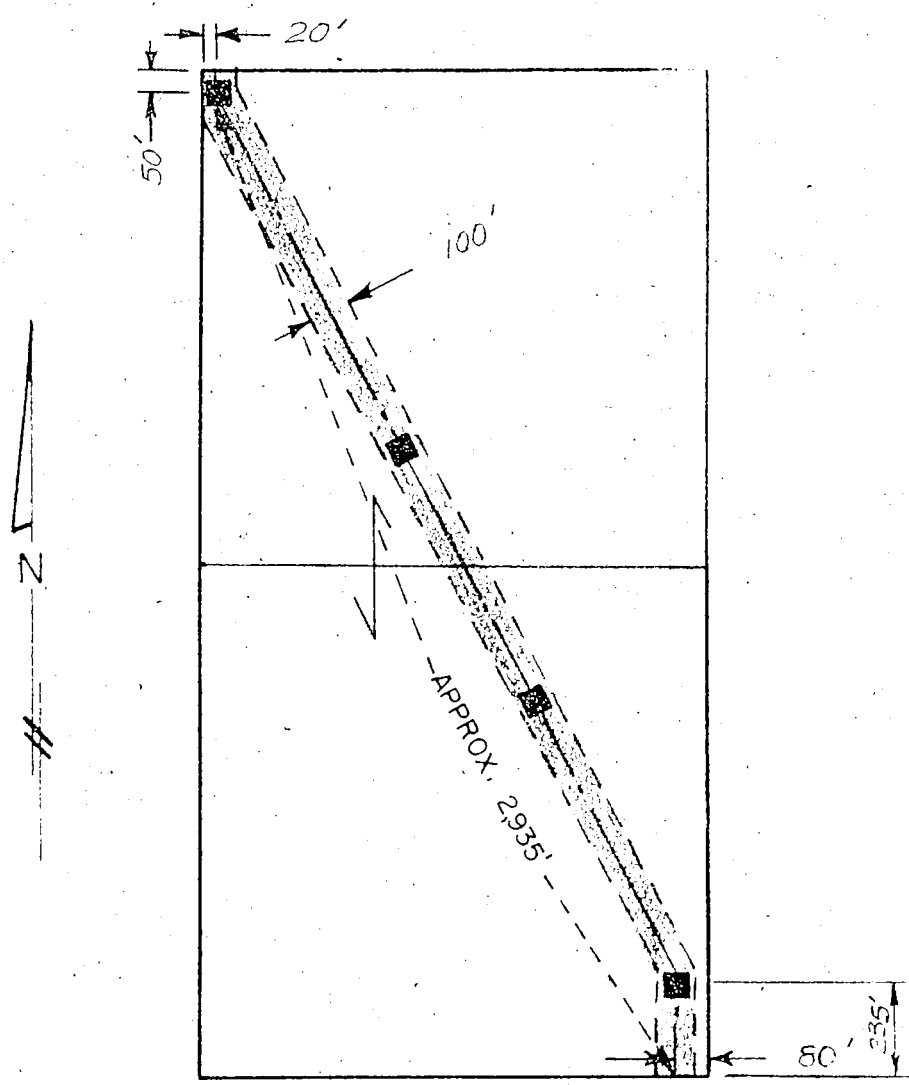

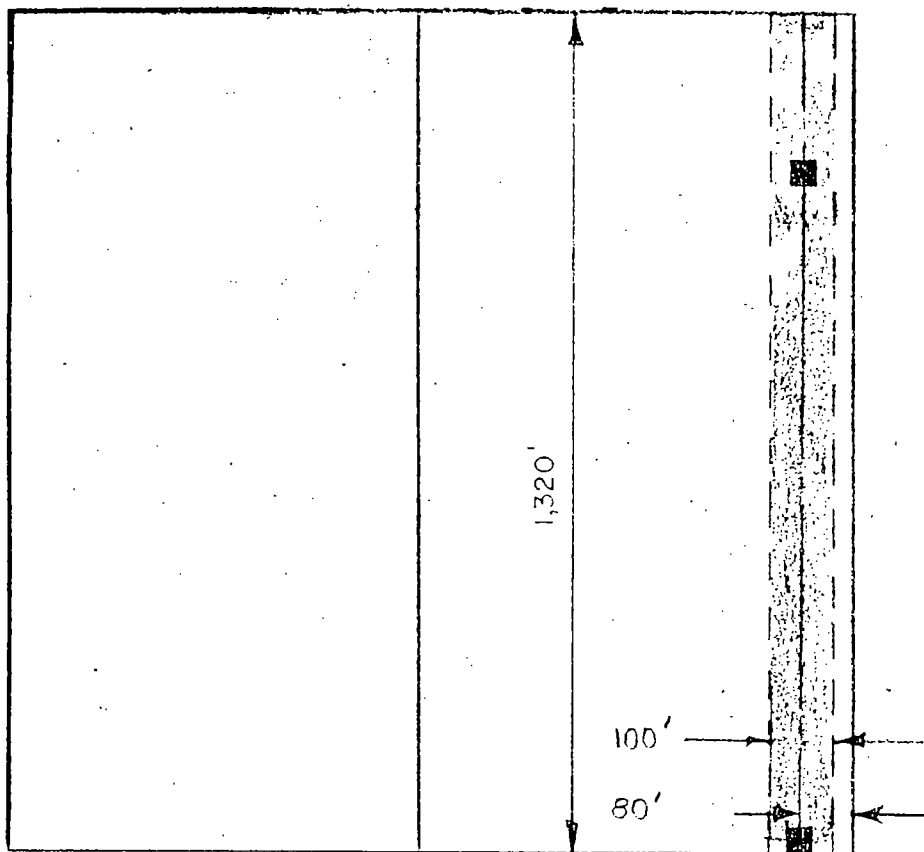

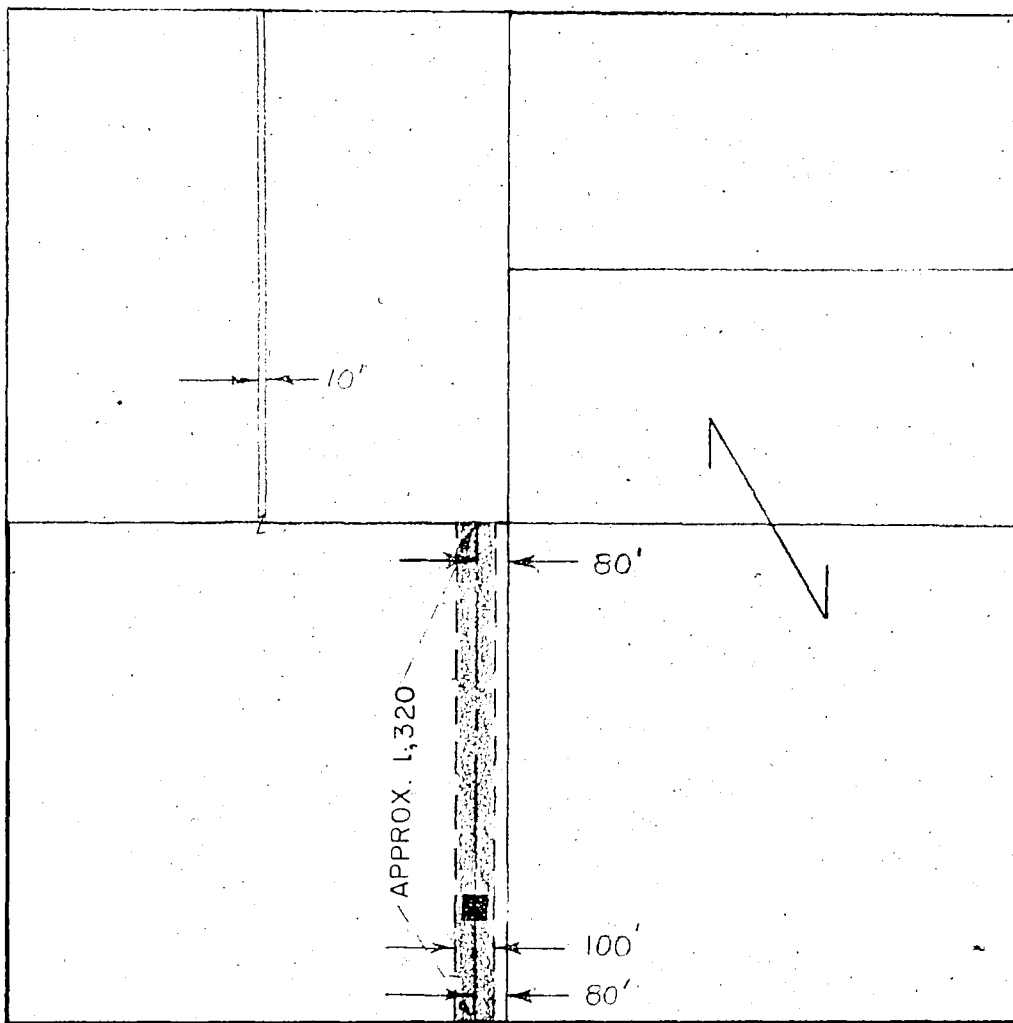

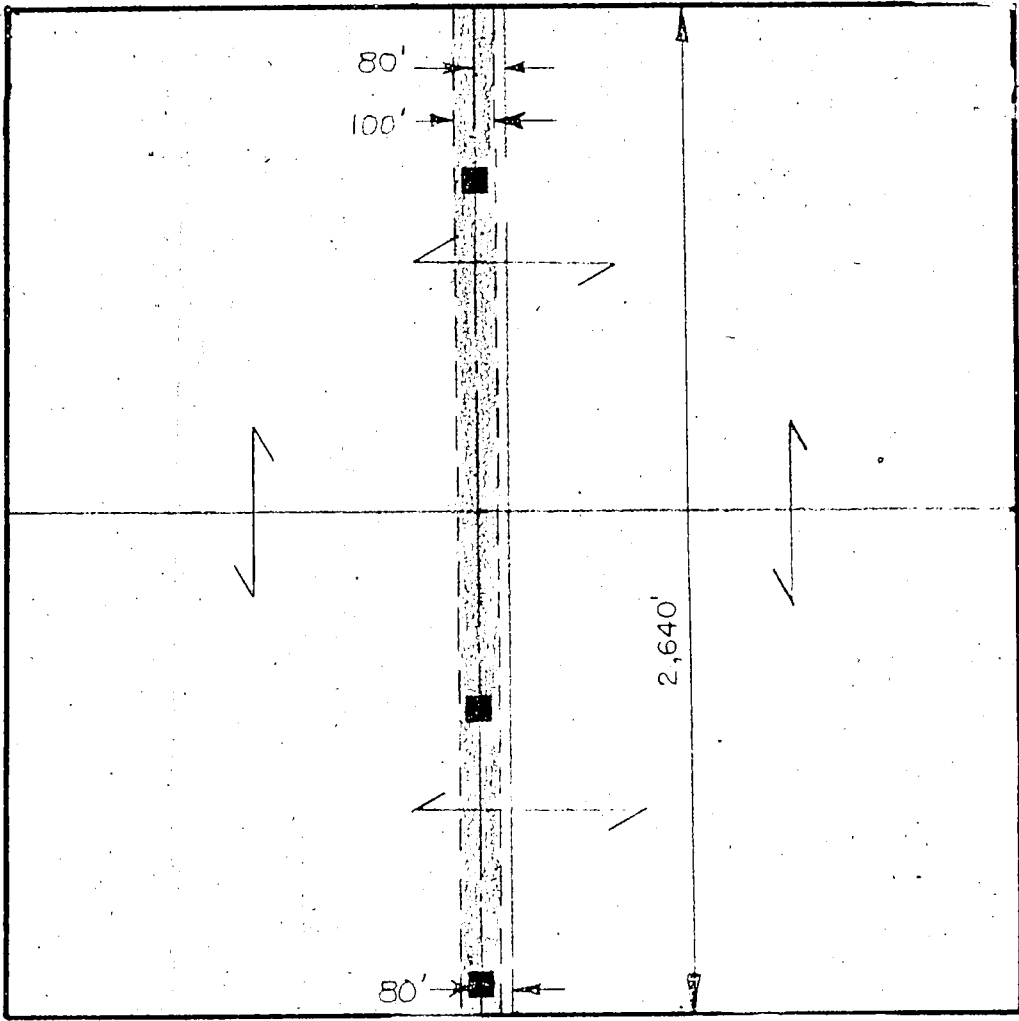

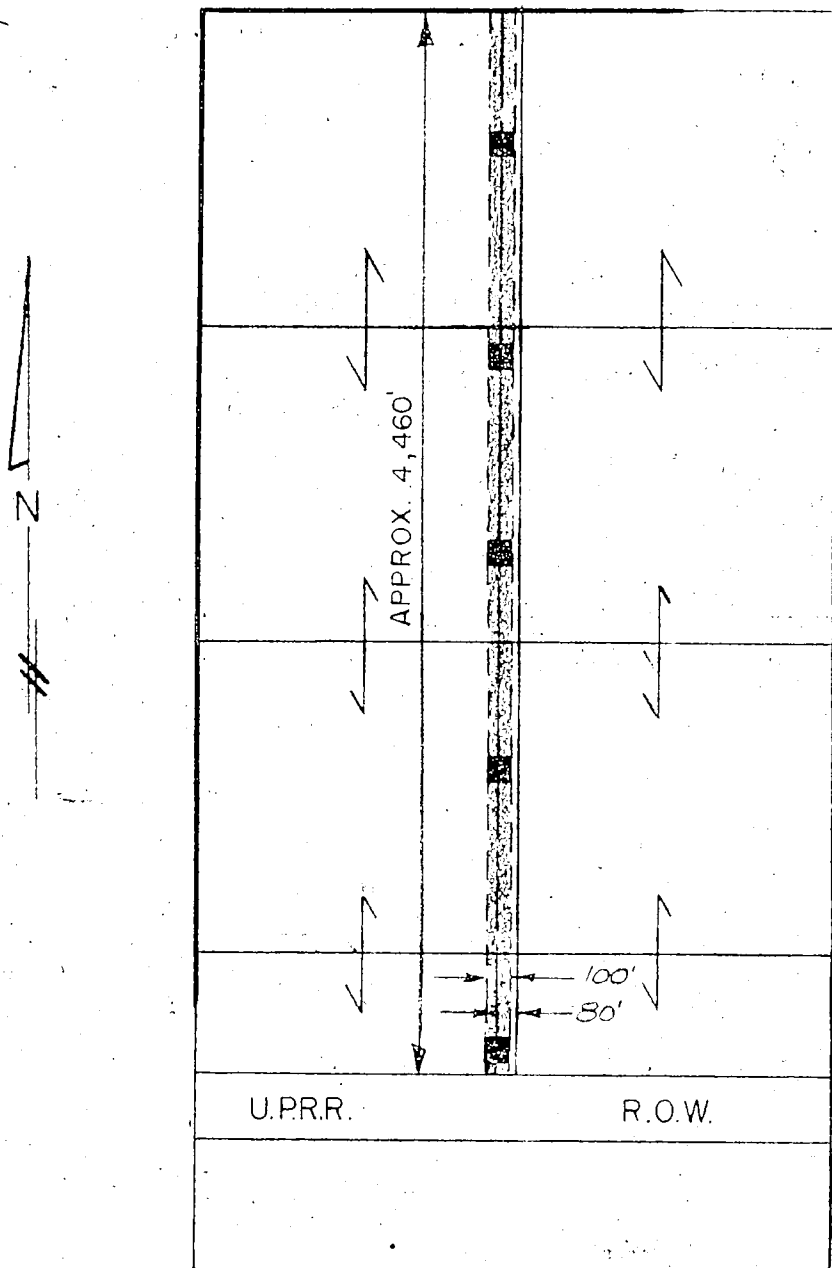


■ APPROXIMATE LOCATION STEEL TOWER STRUCTURE
