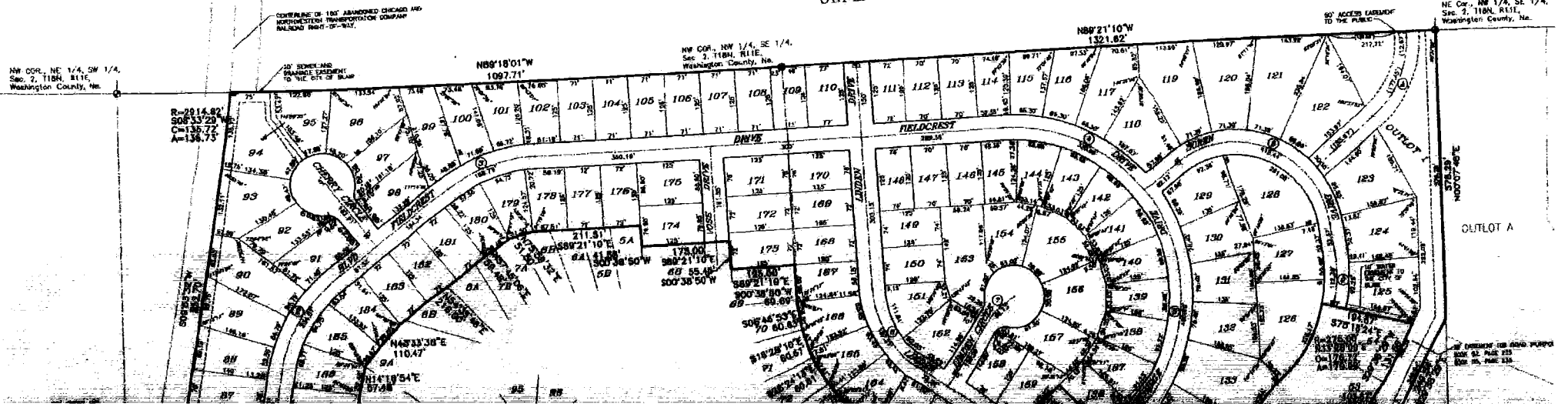

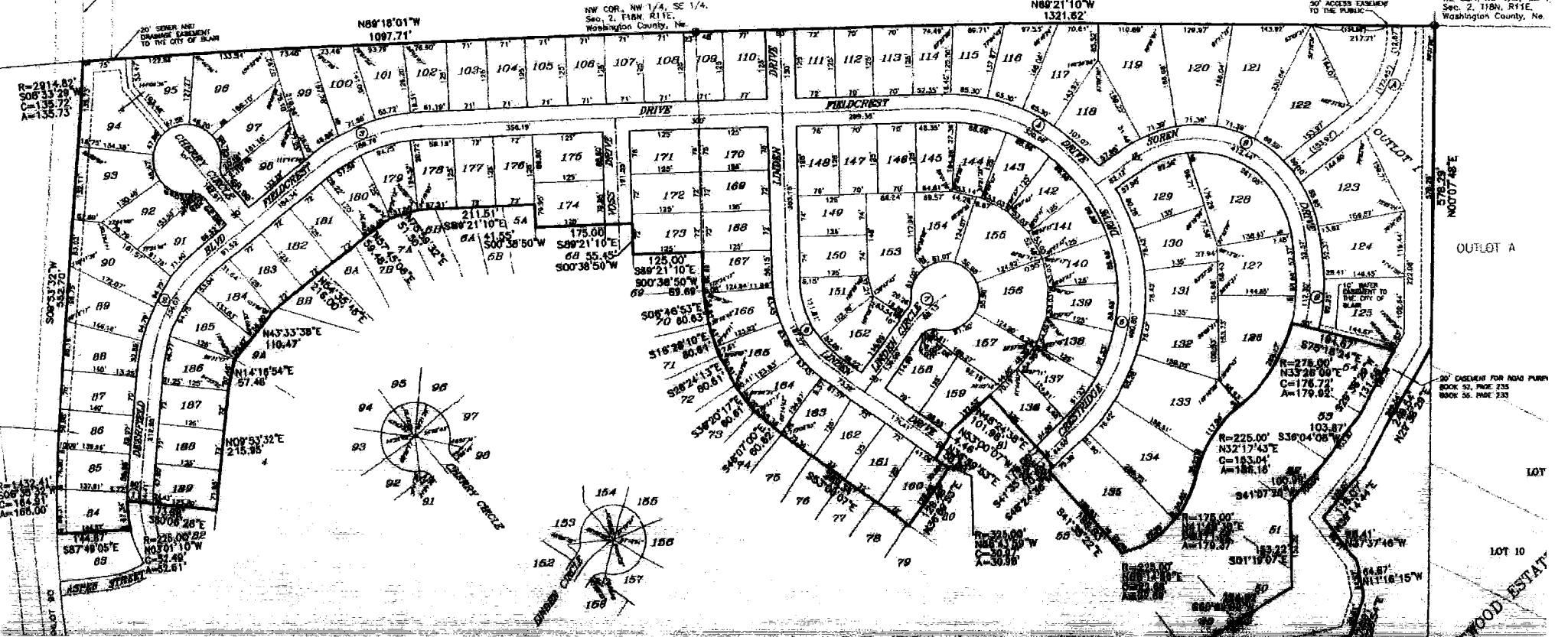

RAILROAD RIGHT-OF-WAY.

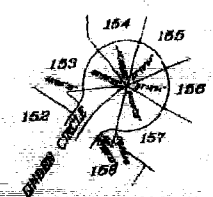
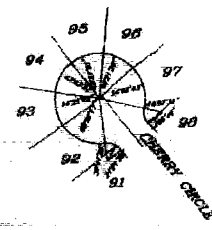
