AN ORDINANCE extending the limits of the City of Gretna, Nebraska over certain land in Sarpy County, Nebraska and incorporating the same into and making the same part of the City of Gretna and to provide the effective date thereof.

BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF GRETNA, SARPY COUNTY, NEBRASKA:

Section 1. That the corporate limits of the City of Gretna be extended over and that there be included therein the following described lands in Sarpy County, Nebraska which presently adjoin the city limits of the City of Gretna, as it now exists:

A tract of land located in the S.W. 1/4 Section 31, T14N, R11E. Sarpy County, Nebraska, and more particularly described as follows: Beginning at the NW corner of the SW 1/4 Section 31, T14N, R11E of the 6th P.M.; thence N 87° 24' 44" E 2427.77'; thence S 2° 46' 23" E 1321.75'; thence S 87° 27' 20" W 2480.38'; thence N 2° 26' 34" W 1319.87' to the point of beginning. Containing 75.093 acres more or less.

A map of the areas attached hereto, marked "Exhibit A", and by this reference made a part of this ordinance. The land to be annexed is marked thereon, but said map is for convenience and, in case of discrepancy, the description in this section shall be controlling. The said territory upon the taking effect of this ordinance shall be and become incorporated into, merged in, be part of the City of Gretna, Nebraska, and subject to the jurisdiction thereof and its laws and ordinances.

Section 2. This ordinance shall be in full force and take effect at 12:01 A.M. August 1, 1989, after its passage, approval and publication or posting as required by law.

Section 3. That any other ordinance passed or approved prior to the passage, approval or publication or posting of

this ordinance and in conflict with its provisions is hereby repealed.

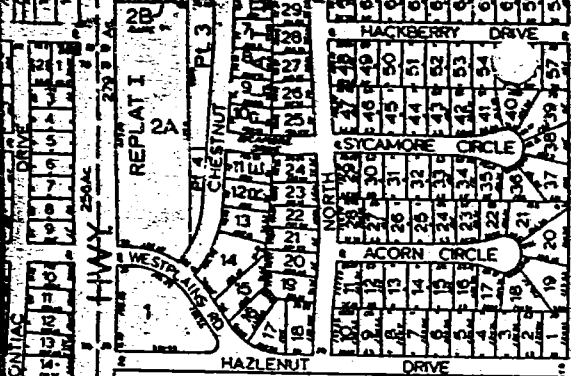

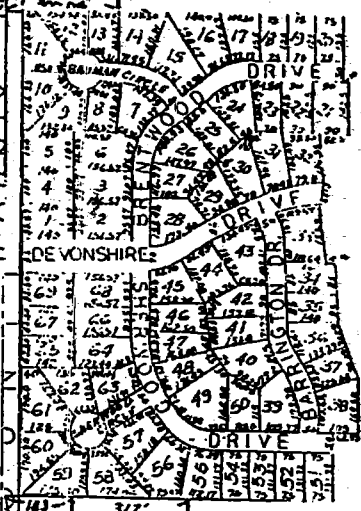
