

STATEMENT

TO WHOM IT MAY CONCERN:

RE: SANITARY AND IMPROVEMENT DISTRICT NO. 252 OF DOUGLAS COUNTY, NEBRASKA.

1. Sanitary and Improvement District No. 252 of Douglas County, Nebraska (SID 252) was created under Decree of the District Court of Douglas County, Nebraska at Appearance Docket 651, Page 248 on August 4, 1977

2. The outer boundaries of SID 252 and the area embraced therein are as follows:

Part of the NE 1/4 of Section 12, T14N, R11E of the 6th P.M., Douglas County, Nebraska, more particularly described as follows: Commencing at the SE corner of the NE1/4 of said Section 12; thence North (Assumed Bearing) on the East line of the said NE1/4, 715.59 Feet to the point of beginning; thence N 56°-53'-36" W, 662.75 Feet; thence N 38°-49'-04" E, 425.26 Feet; thence N 55°-15'-00" W, 105.41 Feet; thence N 34°-45'-00" E, 227.50 Feet; thence N 48°-00'-38" E, 49.42 Feet to a point on the centerline of Papillion Creek; thence northwesterly on the centerline of said Papillion Creek, 1500 Feet more or less to a point on the South R.O.W. line of "Q" Street, said point being 100.00 Feet South of the North line of said NE1/4; thence westerly on a line 100.00 Feet South of and parallel to the North line of said NE1/4, 1030 Feet more or less; thence southwesterly on the Southerly R.O.W. line of said "Q" Street, 185.0 Feet; thence southerly on the easterly R.O.W. line of 138th Street, 292.9 Feet to a point 33.0 Feet East of the West line of the said NE1/4; thence westerly 33.00 Feet to a point on the said West line of the NE1/4, said point being 460.9 Feet South of the NW corner of the said NE1/4; thence southerly on the West line of the said NE1/4, 1995.1 Feet more or less to a point 190.00 Feet North of the SW corner of the said NE1/4; thence southeasterly 205 Feet more or less to a point 200.00 Feet East of the West line of the said NE1/4; thence southerly on a line 200.00 Feet East of and parallel to the West line of the said NE1/4, 150.00 Feet to a point on the South line of the said NE 1/4; thence easterly on the said South line of the NE1/4, said line also being the North line of Timber Creek, a subdivision as surveyed, platted and recorded in Douglas County, 1794.2 Feet more or less to the SW corner of the SE 1/4 of the SE1/4 of the said NE1/4; thence northerly on the West line of

the said SE 1/4 of the SE 1/4 of the NE 1/4, 661.9 Feet more or less to the NW corner of the said SE 1/4 of the SE 1/4 of the NE 1/4; thence easterly on the North line of the said SE 1/4 of the NE 1/4 of the NE 1/4, 663.4 Feet more or less to a point on the East line of the said NE 1/4; thence North on the said East line of the NE 1/4, 53.5 Feet more or less to the point of beginning.

3. The purposes for which SID 252 is formed are installing electric service lines and conduits, installing a sewer system, installing a water system, installing a system of sidewalks, public roads, streets and highways, to contract for water, for fire protection and for resale to residents of the District, and to contract for gas and for electricity for street lighting for the public streets and highways within SID 252, and to acquire, improve and operate public parks, playgrounds and recreational facilities. SID 252, in lieu of establishing its own water system, may contract with any Utility District, municipality or corporation for the installation of a water system and to provide water service for fire protection and for the use of residents of the District.

4. SID 252 has the power to levy an unlimited property tax to pay its debt and its expenses of operation and maintenance.

5. SID 252 is required to levy special assessments on property in the District to the full extent of special benefits arising by reason of improvements installed by the District.

6. The annual budget of SID 252 is filed with the County Clerk, which budget shows the anticipated revenue and expenses, mill levy and indebtedness of the District.

7. The actual current mill levy amount of SID 252 may be obtained from the County Clerk.

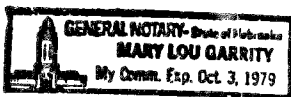
8. A copy of the annual financial audit of SID 252 is on file with the Clerk of the District and the Auditor of Public Accounts of the State of Nebraska.
