ELEVATED CROSSING AGREEMENT

For and in consideration of the sum of One (\$1.00) Dollar and other valuable consideration to us in hand paid by GREAT LAKES PIPE LINE COMPANY, a corporation, of Kansas City, Missouri, receipt of which is hereby acknowledged, August Lad and Mary Lad, his wife, do hereby grant to GREAT LAKES PIPE LINE COMPANY, its successors or assigns, the right to construct, maintain, operate, repair, rebuild and replace at any time approximately 100 feet of its pipe line on pipe lines on elevated supports above the surface of the ground and to remove the same at any time with the right of ingress and egress to and from the same, on, over and through certain lands situate in the County of Sarpy and State of Nebraska and described as follows:

NW $\frac{1}{4}$ of NW $\frac{1}{4}$ Sec. 27 and E $\frac{1}{2}$ of NE $\frac{1}{4}$ Sec. 28; and Tax Lot #2, Sec. 21 (Sec. 28, 27, 21)
Township 13 $\frac{1}{2}$ Range 13 $\frac{1}{2}$ of NE $\frac{1}{4}$

It is further agreed and understood that the GREAT LAKES PIPE LINE COMPANY, its successors or assigns, shall pay all damages to crops, surfaces, fences and other improvements which may be suffered by reason of the construction, maintenance and operation of said elevated lines.
