AN ORDINANCE creating Sidewalk Improvement District No. 85, defining the limits thereof, providing for the construction, reconstruction, replacement, or repair of public sidewalks therein, providing for the payment of the cost thereof, designating the property to be benefited, providing for the acquisition of easements and additional right-of-way, if necessary, and repealing all ordinances or parts of ordinances in conflict herewith.

BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

Section 1. That Sidewalk Improvement District No. 85, of the City of
Lincoln, Nebraska, be and the same is hereby created, that said Sidewalk
Improvement District shall include that area bounded on the north by Holdrege
Street; on the east by 70th Street; on the south by "A" Street; and on the
west by 48th Street; with construction, reconstruction, replacement or repair
of sidewalks as approved by the Director of Public Works for the following
described real estate benefited to-wit: All those properties legally described
in the attached "Exhibit A" which is hereby incorporated herein.

The cost of constructing, reconstructing, replacing or repairing the sidewalks in said District, including the cost of grading the sidewalk space and public street between the curb line and the property line and all expenses incidental to all of this improvement shall be assessed against the property benefited in said District in proportion to the benefits not exceeding the cost thereof. In the event that easements or additional right-of-way must be acquired for the completion of this district, such property rights may be acquired by negotiation and purchase or by condemnation, if necessary, as provided by law.
