SURVEYORS CERTIFICATE

I, E. Gerald Erickson, surveyor of Wahoo, Saunders County, Nebraska, hereby certify as follows: That I have accurately surveyed and staked the lots of Suburban Homes Addition No. 2 to the Village of Elkhorn, Douglas County, Nebraska, as shown on the attached plat and that the description of the outer boundaries of this addition are as follows:

A tract of land in the NE 1/4 of Section 12, Twp. 15 N., Range 10 East of the 6th. PM., Douglas County, Nebraska, more particularly described as follows:
