MEMORANDUM OF AGREEMENT FOR ELMWOOD TOWNHOMES, Lots 1-20

WHEREAS, the City of Omaha, Nebraska (the "City") and Elmwood Townhomes, LLC (the "Developer"), a Nebraska limited liability company, having an office for the transaction of business at 2285 South 67th Street #250, Omaha, Nebraska, did on or about the 3rd day of May, 2022, make, execute and deliver, each to the other, a Subdivision Agreement (the "Agreement"), under which Developer agreed, in accordance with the terms of the Agreement, to develop and maintain certain real property located within the City and is or shall be more particularly described as follows:

Lots 1-21, Elmwood Townhomes, as further described on Exhibit "A" attached hereto (hereinafter referred to as the "Development Property"); and

WHEREAS, the City and Developer desire to record a Memorandum of the Agreement referring to the Development Property and their respective interests therein.

NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

- 1. The recording of this Memorandum of Agreement for Elmwood Townhomes, Lots 1-20 shall serve as notice to the public that the Agreement contains 1) provisions regulating and restricting development and use of the Development Property, 2) the improvements to be installed, located and/or operated on such Development Property, and 3) ongoing and future rights and duties of the Developer (or their successors and assigns). Lot 21, Elmwood Townhomes, is part of the Development Property but is not subject to the terms of Section 4 herein.
- 2. All of the provisions of the Agreement and any subsequent amendments thereto, if any, even though not set forth herein, are by the filing of this Memorandum of Agreement for Elmwood Townhomes, Lots 1-20 made a part hereof by reference. Anyone making any inquiry or claim regarding any of said Development Property in any manner whatsoever shall be fully

advised as to all of the terms and conditions of the Agreement, and any amendments thereto, as if the same were fully set forth herein.

- 3. A copy of the Agreement and any subsequent amendments thereto, if any, shall be maintained on file for public inspection during ordinary business hours in the office of the City Clerk, Omaha, Nebraska.
- 4. The topics, regulations, rights, and duties contained in the Agreement include, but are not limited to, the following:
 - a. The owners of Lots 1-20, Elmwood Townhomes, shall be members of Elmwood Townhomes Owners Association.
 - b. All permanent maintenance (including repair, upkeep, replacement, and snow removal) of the pavement in Outlot A, Elmwood Townhomes, shall be the responsibility of the owners of Elmwood Townhomes Owners Association.
 - c. Some of the lots within the subdivision do not have frontage to public right-of-way and/or a public street. Such lots will be served by a paved access that will be privately maintained; no maintenance will be performed on this access by the City.
