## EASEMENT AND RIGHT OF WAY

That Grantor, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, does hereby grant to Metropolitan Utilities District of Omaha, its successors end assigns, an easement and right of way to lay, maintain, operate, repair, relay and remove, at any time, pipelines for the transportation of gas and water, and all appurtenances thereto, together with the right of ingress and egress to and from the same, on, over, under and through lands described as follows: as follows:

Several strips of land lying in Lots 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, and 41, of Escalante Hills Replat II, a subdivision, as now platted and recorded, in Douglas County, Nebraska, said strips being more particularly described as follows: described as follows:

All that portion of Lots Three (3), Your (4), Five (5), Six (6), Seven (7), Eight (8), and Nine (9), lying within Five (5) feet of, along and parallel to the right-of-way line of 109th Avenue Circle;

All that portion of Lots Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Fifteen (15), Sixteen (16), Seventeen (17), Eighteen (18), Nineteen (19), Twenty (20), and Twentyone (21), lying within Five (5) feet of, along and parallel to the right-of-way line of 110th Circle;

- 2. Grantee shall restore the surface of the soil excavated for any purpose hereunder, as near as may be reasonably possible, to the original contour thereof and as soon after su h work is performed as may be reasonably possible to do so.
- 3. Nothing herein contained shall be construed as a waiver of any rights of Grantor, or duties and powers of Grantee, respecting the owner-ship, use, operations, extensions and connections to any pipeline con-structed and maintained hereunder.




