AMENDMENTS TO DECLARATION

AMENDMENTS TO DECLARATION made on the date hereinafter set forth by more than ninety percent (90%) of the lot owners of Escalante Hills Property Owners Association, Inc., as of the date hereof.

W I T N E S S E T H :

WHEREAS, the lot owners, in order to preserve and promote the private residential character of the premises in accordance with the plan of development expressed in the original Declaration and all supplemental Declarations and amendments are desirous of amending the Declarations as they relate to certain responsibilities of Escalante Hills Property Owners Association, Inc.

WHEREAS, certain lot owners, commonly known as the duplexes, are desirous of withdrawing from the Escalante Hills Property Owners Association, Inc., and

WHEREAS, it appears in the best interests of all property owners concerned to allow for the withdrawal,

NOW, THEREFORE, in accordance with the foregoing preambles, the undersigned declare that the following property shall be withdrawn from the Escalante Hills Property Owners Association, Inc., as set forth:

1. That Lots 28 through 38, inclusive, and Lots 42 and 43, being those lots containing the duplexes in question, and more particularly described in Exhibit B attached hereto and made a part hereof (hereinafter "duplex lots"), are released from all future obligations relating to Escalante Hills Property Owners Association, Inc. as set forth in those certain covenants, easements, restrictions, and conditions (hereinafter referred to as "Declarations"), dated August 21, 1972, and recorded at Page 459 through Page 467, inclusive, of Book 513, of the miscellaneous records of the Register of Deeds of Douglas County, Nebraska, and amendments and supplemental declarations; further, said duplex lots are hereby allowed to withdraw from said Escalante Hills Property Owners Association, Inc.

2. Escalante Hills Property Owners Association, Inc. is hereby relieved of all obligations and responsibilities, past or future, that arise out of the Declarations, dated August 21, 1972, and recorded at Page 459 through 467, inclusive, of Book 513 of the miscellaneous records of the Register of Deeds of Douglas County, Nebraska, and amendments and supplemental declarations thereto concerning Lots 28 through 38, inclusive, and Lots 42 and 43, being the lots containing the duplexes in question and more particularly described in Exhibit B.

3. Sanitary and Improvement District No. 235 has approved this Amendment to Declaration by the signature of the Chairman and Clerk.
