## MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT entered into this 24 day of January, 2002 between US Bank National Association ("USB"), 601 Second Avenue South, Minnesota 55402, and RPI Limited Partnership No. 14, a Nebraska limited partnership, 1600 University Avenue, Suite 212, St. Paul, MN 55104 ("RPI"), for the purpose of giving notice of a Parking Agreement (the "Agreement") between the parties affecting certain real estate located in the City of Omaha, Douglas County, Nebraska, and more particularly described as follows:

The east 44 feet of Lot 6, together with Lot 7, except the east 1 foot thereof, Block 140, original City of Omaha, as surveyed and lithographed, in Douglas County, Nebraska.

- 1. **DATE OF AGREEMENT AND TERM**. The Agreement was entered into effective February 1, 1998, and is for a term of 20 years commencing January 1, 1998, ending December 31, 2017.
- 2. NATURE OF AGREEMENT. Subject to the terms of the Agreement, USB agreed to make available to tenants of RPI up to sixty (60) parking stalls located on the subject property. Thirty (30) of such stalls are specifically designated. The balance of such parking stalls are made available to RPI pursuant to the terms of the Agreement. Subject to the terms of the Agreement, RPI has a right of first refusal to purchase parking spaces in the event USB places such spaces for sale as individual units. FOR FURTHER PARTICULARS YOU ARE REFERRED TO THE AGREEMENT.
- 4. **NO MODIFICATION**. This Memorandum is entered into solely for the purpose of memorializing the parties' existing Agreement. Nothing herein shall be deemed a modification, amendment or waiver of any of the terms of the Agreement.


