BURIED EXCHANGE FACILITY EASEMENT

The undersigned owner(s) of an interest in the real estate described below (hereinafter called "Owner") hereby grant(s) and convey(s) to NORTHWESTERN BELL TELEPHONE COMPANY, an Iowa corporation, its associated and allied companies, its and their respective successors, assigns, lessees and agents (hereinafter called "Company"), in consideration of the sum of Seven thousand six hundred and

Fifty and no/100----- (\$7650.00) -----Dollars received from the Company and of the agreements stated below, a right-of-way and easement to construct, operate, maintain, replace, and remove a communications system consisting of buried cable or conduit, surface terminals, surface markers (at fence lines, if any) and associated equipment, together with the right of access thereto for the purpose of exercising the rights herein granted, upon, under the across the following described real estate located in the County of Douglas, State of Nebraska.

- West 1/2 of Section 24-15-11
and the SW 1/4 of Section 13-15-11

Said easement to include five feet (5') on either side of a north-south line parallel to and 147' east of the center line of 144th Street extending from the south property line abutting Pacific Street to the north property line in Section 13 with the exception that the line will vary to the west to cross the front of the Service Building at 60' east of the center line of 144th Street. See attached sketch.

Easement will further include ten feet (10') adjacent to the north property line extending from 144th Street east for 152'.

The Company agrees to bury all cables and conduit at a depth to not interfere with owners usage of the land, and to pay for all damage to Owner's property arising from the Company's exercise of the rights herein granted, except as stated below: Exceptions (if any):

Owner specifically reserves the right to require Company to move, at the Company's expense, its facilities installed hereunder to another portion of Owner's property if Owner requires the property occupied by Company for the purpose of constructing a building or buildings.

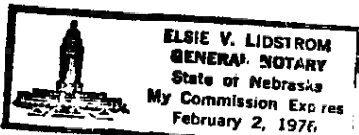
