AGREEMENT

WHEREAS, REED HOLDING COMPANY, a corporation organized under the laws of the State of Nebraska, is owner in fee of the following described real estate, to-wit:

Lot 14, except East 110 feet, and except that part taken for Underwood Avenue, in Fairacres,

and

WHEREAS, the owners of the four above mentioned parcels of real estate are desirous by mutual covenants, of restricting the use of said real estate as hereinafter set forth,

NOW, THEREFORE, in consideration of the premises and the mutual promises herein set forth, IT IS MUTUALLY AGREED by and between the parties hereto:

- 1. The above mentioned parcels of real estate shall be occupied and used for residence purposes exclusively from the date hereof until the first day of January, 1950.
- 2. No building on any of the above mentioned parcels of real estate, nor any part nor projection thereof, except the cornice of the roof, shall at any time within said period be erected or located on said parcels of real estate North of a line parallel to and 185 feet North of the South line of said parcels, except that an open porch and roof thereon or a terrace may be attached to the building North of said line.
- 3. No building shall be erected on any of said parcels of real estate within said period other than a single detached dwelling built thereon, with necessary outbuildings, and such dwelling shall not be less than one and one-half stories in height and the cost of such dwelling, exclusive of outbuildings, shall not be less than Ten Thousand and no/100 Dollars (\$10,000.00).

- 5. Subject to the right of the Nebraska Power Company and the Northwestern Bell Telephone Company, their successors, lesses and assigns, to construct and maintain underground conduits in, and a joint pole line over and upon the rear boundary line of said above mentioned parcels of real estate.
- 6. Each of the conditions and covenants aforesaid shall run with and bind each of said parcels of real estate herein described and every part thereof, and be binding upon all persons who shall be the owners thereof during said period and the parties hereto bind themselves, their executors, administrators, assigns, or successors in interest, or grantees, to observe and perform all the conditions and restrictions hereinbefore mentioned.
