- 1. All lots in Fair Haven Second Addition, whall be used for single family dwellings only. If a garage is built, it shall be an attached garage or carport or basement garage. He detached garage will be permitted.
- 2. No dwelling shall be constructed on any percel of ground less than a whole let as the lots are now platted.
- 3. No dwelling shall be constructed measure than 30 feet from the front lot line, excluding steps and epen perches, and no dwelling shall be constructed measure than 5 feet from the side lot line excepting on corner lots the side yard shall be 15 feet from the side street.
- 4. Only one story or one and one-half story dwellings shall be permitted and they shall contain the following minimum square footage:
 - (A) One story dwelling, not less than CSO square feet, exclusive of garage and spen perches.
 - (B) One and one-balf story dwelling, the first story shall not contain less than 850 square feet, and the floor space in such dwelling to be not less than 1600 square feet or more.

A perpetual essement of five feet is hereby granted to municipal corporations and public utility corporations, all telephone and electric lines are to be in the reer of such of said dwelling houses, except when such construction is impossible. Water lines and gas lines may be laid in the streets adjacent to said lots.

- No observance or offensive trade which is ar might become a nuisance to the residents of said addition shall be permitted.
- 8. He let er part of let shell be used as a desping ground for rubbish nor shell the owner of any let parmit woods to grow. Trash or garbage shall be kept in a closed container at the rear of all lots until disposed of.
- 9. We poultry nor animals of any kind shall be reised or kept on any let, except dogs or cats used as household pets, and they are not to be kept or maintained for breeding purposes, or for conmercial use.
- No commercial signs of any kind shall be erected on any lot, except temperary signs of builders or material companies.

13. Each and every prevision herein shall bind and inure to the besefit of the undersigned, their successors and assigns, heirs or legal representatives.

Any violations of these covenants or the zoning restrictions now in force shall be punishable under the zoning restrictions now of record. These covenants are to enlarge upon the zoning restrictions and no part of same shall be in conflict with the zoning restrictions now of record in Marpy County, Nebrasks, and covering this property.
