I hereby certify that under my supervision, a tract of land located in the NW 1/4 of the SW 1/4 of Section 36, Township 14 North, Range 10 East of the 6th P.M., Sarpy County, Nebraska, was surveyed and staked with iron pins as shown on this plat. Commencing at a point on the west line of Wessgaye St. 50' west of the north-west corner of Lot 9-Fair Haven Addition; thence southerly along said west line of Wessgaye St. a distance of 594'; thence westerly with an interior angle of 90°00' a distance of 120'; thence north-westerly with an interior angle of 90°00' a distance of 454'; thence north-easterly with an interior angle of 143°08' a distance of 50'; thence northerly with an interior angle of 216°52' a distance of 100'; thence easterly with an interior angle of 90°00' a distance of 90' to the point of beginning, being a part of Tax Lots "D" and "D1" and to be known hereafter as FAIR HAVEN SECOND ADDITION.

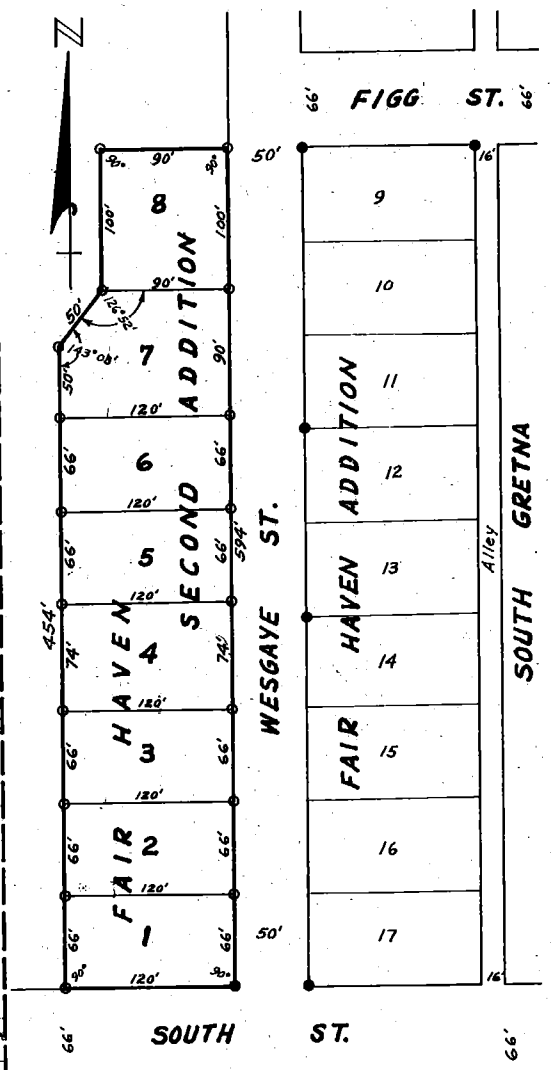
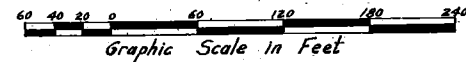
