SURVEYOR'S CERTIFICATE

I hereby certify that under my supervision a tract of land located in the NW 1/4 of the SW 1/4 of Sec. 36, Twp. 14 N., R. 10 E. of the 6th P.M., Sarpy Co., Nebr. was surveyed and staked with iron pins as shown on this plat. Commencing at a point 587' west of an existing iron stake at the NE corner of Block 5 - South Gretna as the point of beginning; thence North 594'; thence West 170'; thence South 1188'; thence East 170'; thence North 594'; to the point of beginning all angles being 90 degrees; being a replat of Lot 15, 16, & 17 in Block 3 - South Gretna, the East 170' of Tax Lot "A" and the East 51' of the South 198' of the North 264' of Laurie Street. 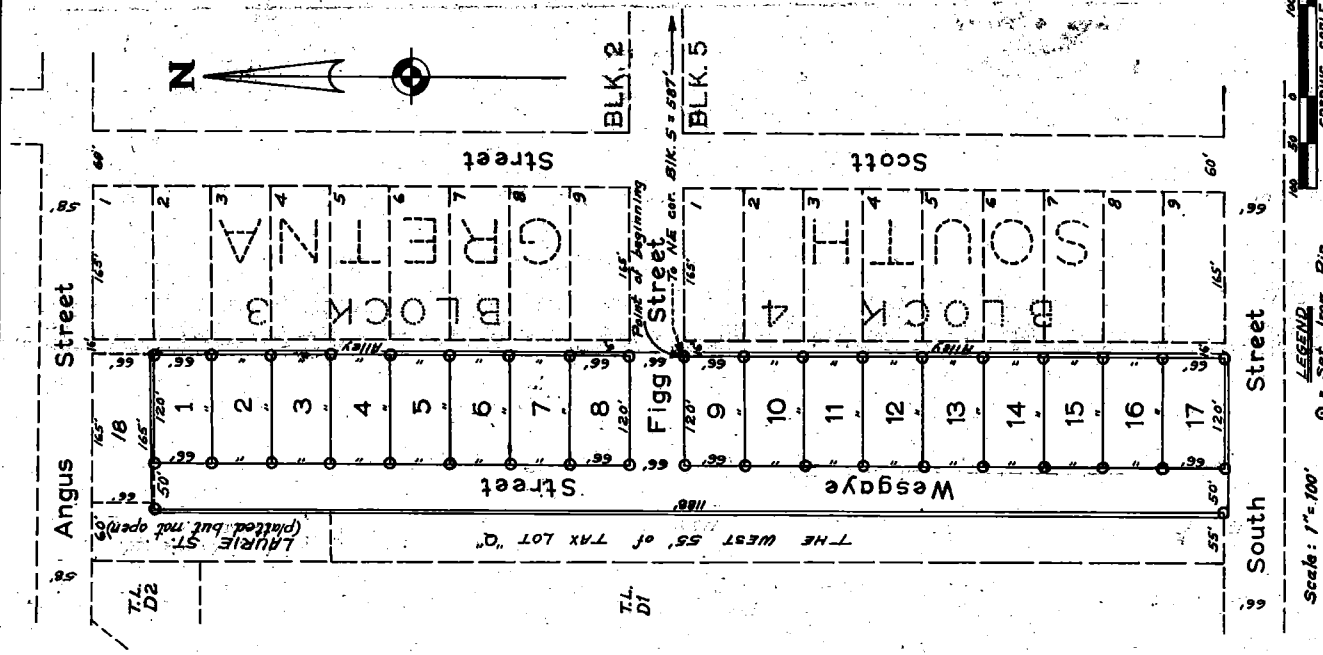
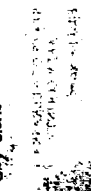
