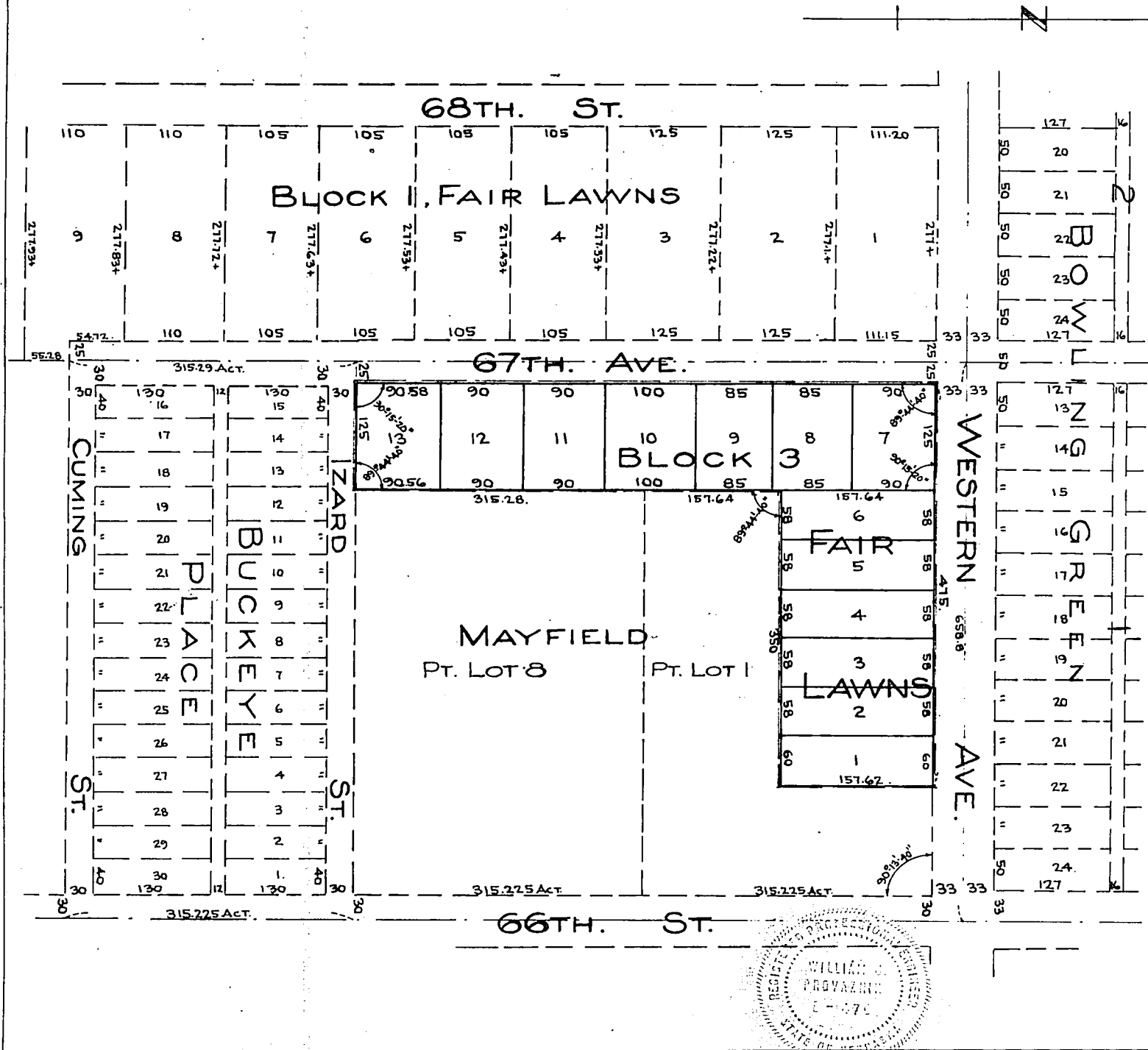


BLOCK 3, FAIR
