ORDINANCE NO. 394

Introduced December 7th, 1915.

By Councilman James L. Johnson.

An Ordinance, vacating all of the alleys running east and west in blocks 92, 95, 99 and 100 and all of the alleys or parts of alleys in blocks 22, 26, 81, 89, 96, 103, 108, 109, 129, 136, 139, 141 and that part of Cook street from the west line of Fifth Street to the east line of Prospect street, and that part of Sargent street from the east line of Fifth street east to the River Road, all in the City of Florence, as surveyed, platted and lithographed.

WHEREAS, the necessary legal proceedings have heretofore been completed for the vacation of all of the alleys, parts of alleys and parts of streets hereinafter described, except those parts of streets and those alleys hereinafter described which the owners of abutting real estate thereon have petitioned this Council to vacate, and

WHEREAS, it is deemed expedient and proper by this Council to vacate all of the following described streets and alleys and parts thereof at this time; Now, therefore,

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF FLORENCE:

Sec. 1. That all of the alleys running east and west in blocks 92, 95, 99 and 100 and all of the alleys or parts of alleys in blocks 22, 26, 81, 89, 96, 103, 108, 109, 129, 136, 139, 141, and that part of Cook Street from the west line of Fifth Street to the east line of Prospect street, and that part of Sargent street from the east line of Fifth street east to the River Road, all in the City of Florence, as surveyed, platted and lithographed, be, and the same hereby are respectively vacated.

Sec. 2. That the City Clerk be, and he is hereby directed, to execute and file in the office of the Register of Deeds of Douglas County, Nebraska, his certificate showing all of said streets and parts of streets and alleys to have been vacated by this Mayor and Council.

Sec. 3. This Ordinance shall take effect and be in force from and after its passage.
