## AMENDMENT TO BYLAWS

OF

## LA VISTA GRAND VILLA ASSOCIATION, INC.

This amendment to Bylaws made and entered into this  $\frac{25\text{th}}{\text{day}}$  of  $\frac{\text{May}}{\text{May}}$ , 1982, by 22 % of the co-owners representing  $\frac{61}{\text{May}}$  % of the basic value of the condominum, hereinafter referred to as "Owners".

## WITNESSETH:

WHEREAS, the Bylaws executed on the 24th day of July, 1973, provided in paragraph 12 for assessments against all apartment owners, and

WHEREAS, the actual costs and expenses incurred by the association, for the collection of the assessments or the placing of a lien on property often exceed the assessment, and

WHEREAS, all assessments must be collected to maintain and operate the association and regime, and

WHEREAS, the Owners desire to modify paragraph 12 to provide an additional provision which allows a lien to be placed upon the apartment for the full amount of the assessment due and owing including all expenses incurred for the establishing of said lien and the collection costs and expenses incurred by the association, to collect assessments, including attorney's fees.

NOW THEREFORE, in consideration of the mutual covenants herein contained and other good and valuable consideration of  $\frac{61}{3}$ % of the total value of the condominum regime it is hereby agreed as follows:

1. Paragraph 12 of the Bylaws show the amended to add the following language:

"Assessments that have become delinquent and are not paid upon demand constitute a lien which will be placed on the apartment for the full amount owed and additionally all expenses incurred in the placement of said lien and collection of said lien, including, but not limited to, court costs, attorneys' fees, filing fees, association expenses incurred as a result of said lien and interest will be added to and included with the

original assessment and will further become the responsibility of the homeowner of the apartment whose assessments are delinquent."
