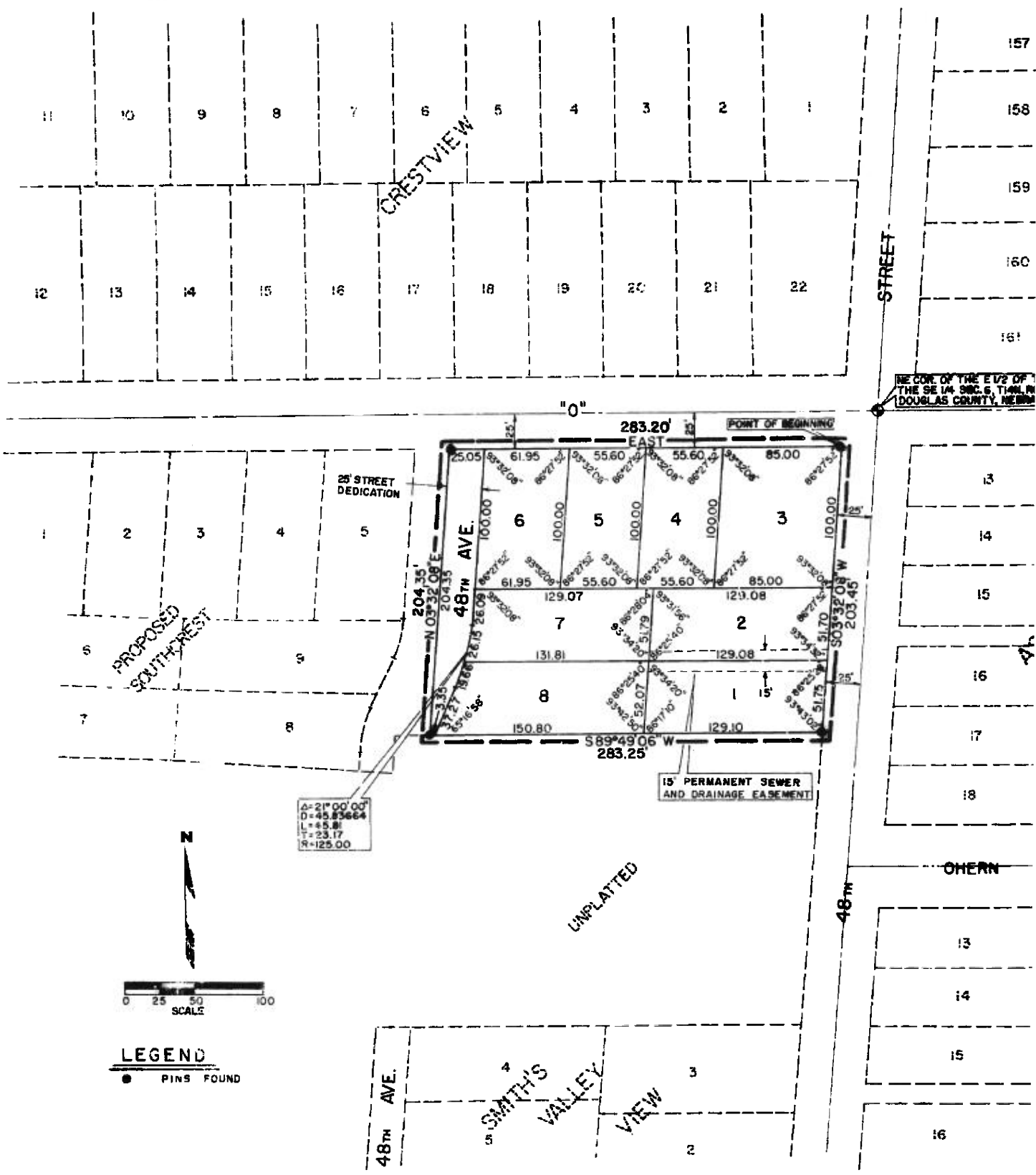

 R13E, OF THE 6TH P.M., DOUGLAS COUNTY, NEBRASKA.



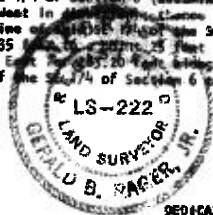

SURVEYOR'S CERTIFICATE

I HEREBY CERTIFY that I have accurately surveyed and staked, with iron pipe, all corners of lots, streets, angle points, and ends of all curves in GREENDALE, Lots 1 thru 6, inclusive, being a platting of that part of the East 1/2 of the SE 1/4 of the SE 1/4 of Section 6, T 14 N, R 13 E of the 6th P.M., Douglas County, Nebraska, more particularly described as follows: Beginning at a point 25 feet East of the East line and 25 feet South of the North line of said East 1/2 of the SE 1/4 of the SE 1/4 of Section 6 (assuming the North line of said East 1/2 of the SE 1/4 of the SE 1/4 of Section 6 to be East-West in accordance with the bearing S 69° 30' 00" W for 203.45 feet along a line 15 feet West of and parallel with the East line of said East 1/2 of the SE 1/4 of Section 6; thence S 09° 00' 00" W for 213.25 feet; thence S 03° 32' 00" E for 204.35 feet; thence East 203.20 feet along a line 25 feet South of and parallel with the East 1/2 of the SE 1/4 of the SE 1/4 of Section 6 to the point of beginning.

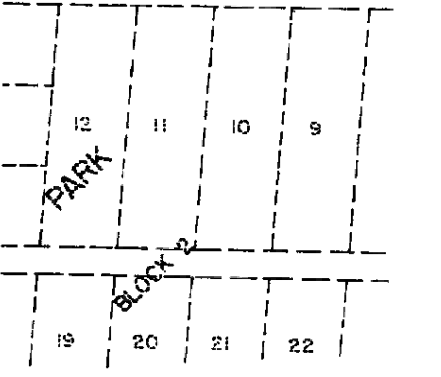
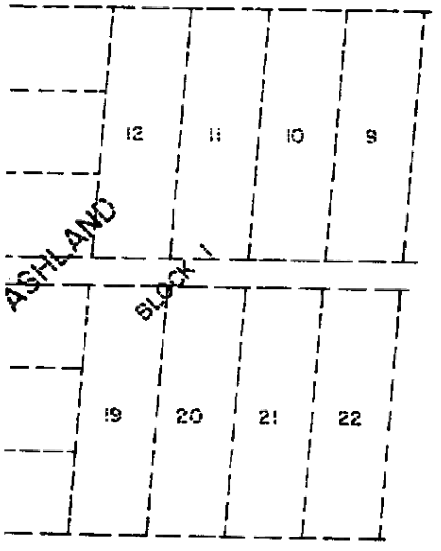
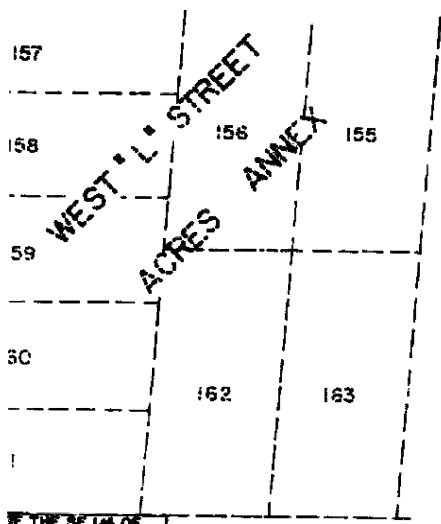
