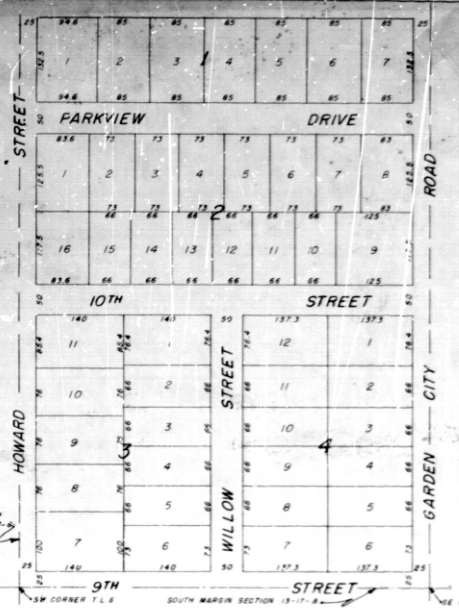
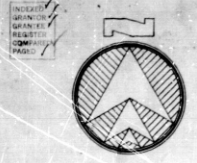

DEDICATION

KNOW ALL MEN BY THESE PRESENTS: That EDWIN E. PRAUNER and VERA L. PRAUNER, husband and wife; HARRY W. STRONG and LUCILLE M. STRONG, husband and wife; ROBERT EDWARD KNOELL and BEVERLY J. KNOELL, husband and wife, and WILLIAM THOMAS KNOELL and DORSAL F. KNOELL, husband and wife are the record title owners of the south 913.9 feet of Tax Lot 6 in the SE 1/4 of the SE 1/4 of Section 13, T17N, R6E of the 9th P.M.  
Being the record title owners of the tract of land described above, we herewith subdivide and plat said tract of land as GANNON SUBDIVISION. The Subdivision is subdivided into blocks numbered from one (1) to four (4) inclusive. All blocks are subdivided into lots with the numbers and dimensions shown on the attached plat.  
We herewith dedicate for perpetual use by the public, PARKVIEW DRIVE, 10TH STREET and WILLOW STREET which are each platted 50 feet in width; GARDEN CITY ROAD, 9TH STREET and HOWARD STREET which are each platted 25 feet in width.  
The undersigned hereby grants to the City of Fremont, any public or private utility company having a franchise from the City of Fremont, and/or reciprocal use by abutting property owners an easement across the rear 100 feet of all lots in this subdivision for the sole purpose of constructing and maintaining utility lines and pipes.  
By affixing our signatures hereto, we do hereby acknowledge this dedication and plating to be our voluntary act and deed.
