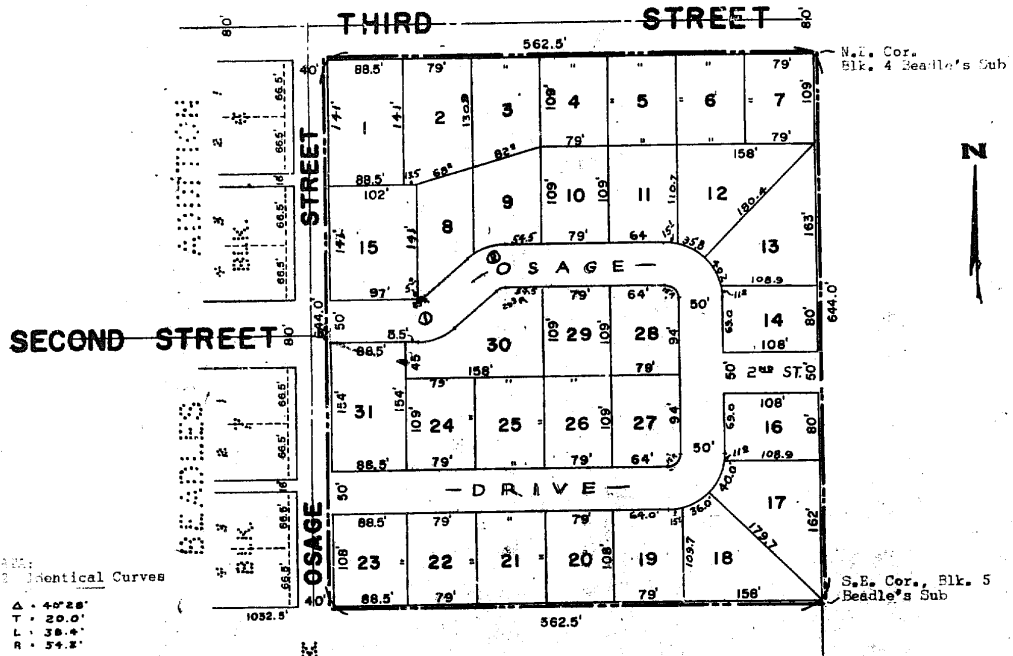

 R = 34.2'

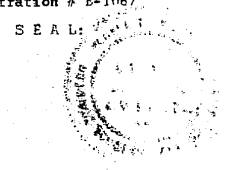

SURVEYOR'S CERTIFICATE

This is to certify that I have accurately surveyed and staked with iron pipes the lots and streets of Gayer Addition, an addition to the City of Papillion, Nebraska. Gayer Addition is a replat of blocks 4 and 5 of Beadles Subdivision; of all vacated valleys in said blocks 4 and 5; vacated second street east of Osage St., and the east 10' of vacated Osage Street from the south edge of Third St. to the north line of First St., if extended, including the east 10' of intersection of Second and Osage Sts. and all more particularly described as follows: Beginning at the S.W. corner of block 5, Beadles Subdivision; thence west along the south edge of said block 5 a distance of 562.5'; thence north on a line parallel to the east edge of Osage St. a distance of 64.0'; thence east along the south line of Third St. extended a distance of 562.5' to northeast corner of Block 4, Beadles Subdivision; thence south along the east line of blocks 4 and 5 of Beadles Subdivision a distance of 64.0' to point of beginning. All lying in the N.W. 1/4 of section 26, T 14N, R 12 E of the 6th P.M. Larv County, Nebr.
