RELEASE OF EASEMENTS

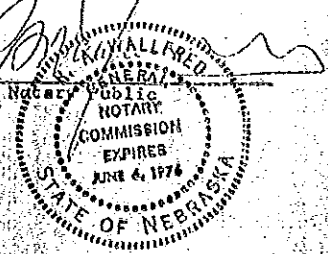
