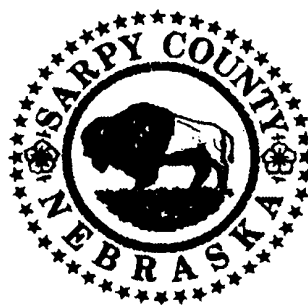

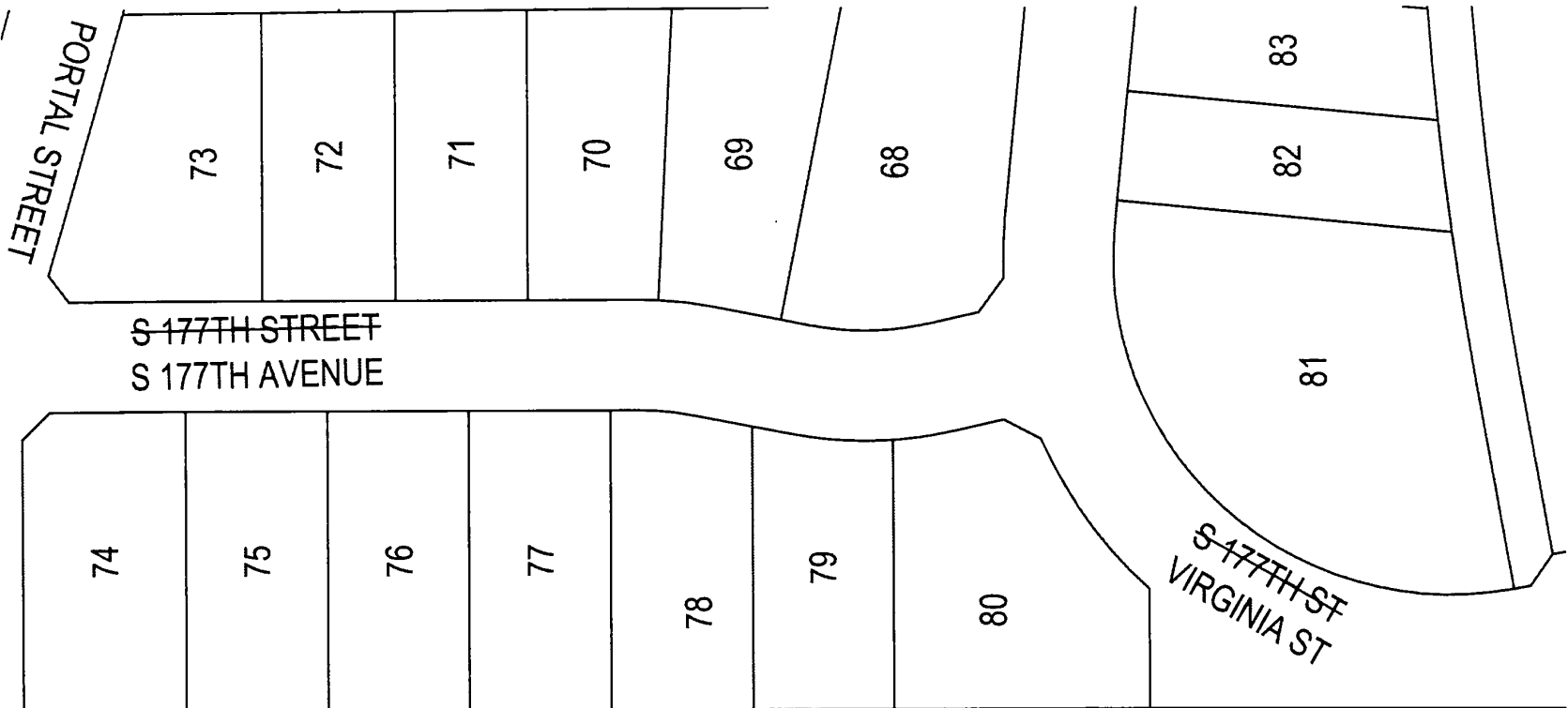

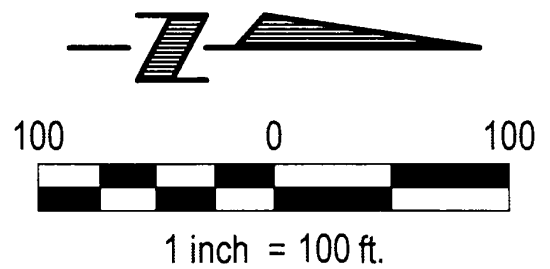

The street names to read Virginia Street instead of S 177TH St, along with S 177TH Avenue instead of S 177TH Street per **SARPY COUNTY**.

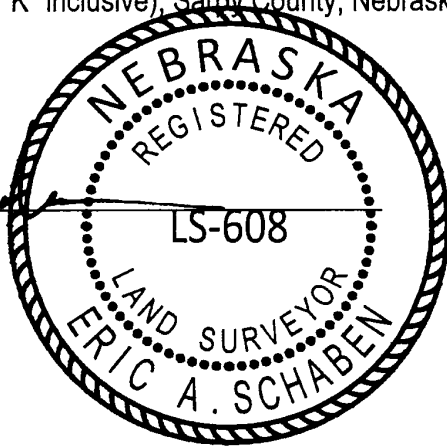
