The Northwest guarter (NK2) of Section 21. Township 14.

TO HAVE AND TO HOLD unto said NORTHERN NATURAL GAS COMPANY, its successors and assigns, so long as such pipe lines, and appurtenances thereto, shall be maintained, together with the right of ingress to and egress from said premises, for the purpose of constructing, inspecting, repairing, maintaining and replacing the property of the grantee located thereon, or the removal thereof, in whole or in part, at the

will of the grantee; it being the intention of the parties hereto that grantors. — are hereby granting the uses herein specified without divesting grantor... of the rights to use and enjoy said above described premises. are hereby granting cubject only to the right of the grantee to use the same for the purposes herein expressed.

As a further consideration for this grant, the grantee herein agrees rs follows:

- (1) That it will bury all line pipe laid upon said land to a sufficient depth so as not to interfere with the cultivation of the soil.
- That it will pay to grantor..... any damages which may arise to growing crops, trees, shrubbery, fences or buildings from the construction, maintenance or operation of said pipe lines, said damages, if not mutually agreed upon, to be ascertained and determined by three dislaterested persons, one of whom shall be appointed by the granter..., one by the grantee, and the third to be exected by the two appointed as aforesaid, and the written award of such three persons shall be final, co clusive and bluding upon the parties hereto.
- (3) That grantee, upon written application by the grantor..., will make, or cause to be made, a tap in any gas pipe line constructed by grantes upon the above described premises for the purpose of supplying gas to grantor.... for domestic purposes only and not for re-sale, and for use upon the above described premises only. All connections required, ab " be furnished and poid for by Grantor with the exception of the meter, which is to be furnished and owned by the Grantee. Said tap will be provided by grantee from a convenient point on its main line or some lateral as the grantee may determine, and gas to be terms as may be established by grantee, or by any vendee of granteto time.
- (4) That grantee will replace or rebuild to the satisfaction representative any and all damaged parts of all drainage systems, the which shall be occasioned by the construction of said pipe lines under and through the above us séd premises.

This instrument, and the covenants and agreements herein contained, shall inure to the benefit of and be binding and obligatory upon the heirs, executors, administrators, successors and assigns of the respective parties.
