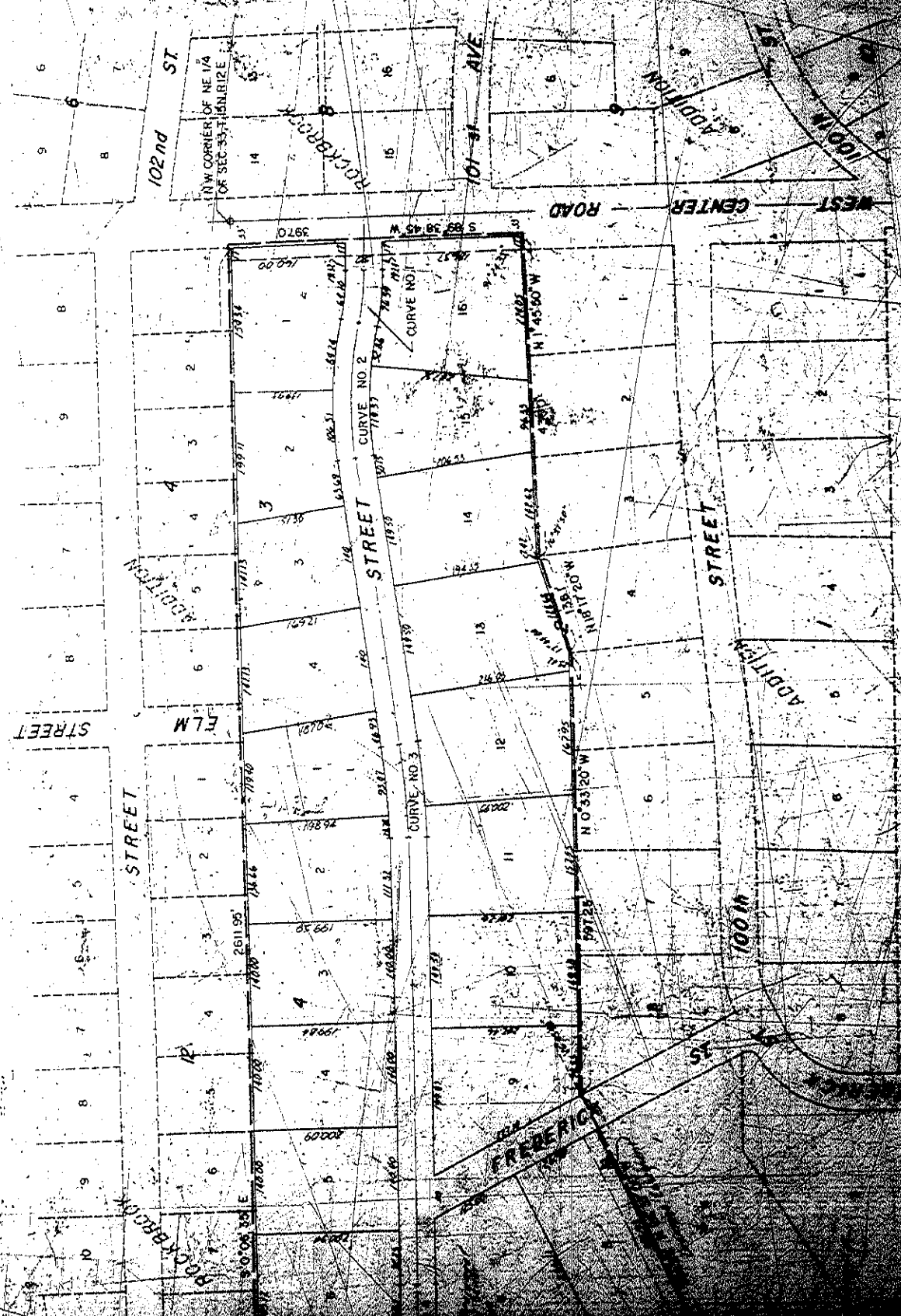


GLEN OAKS ADDITION
