in consideration of Two thousand

in hand paid, do hereby Grant, Bargain, Sell, Convey and confirm unto Christian Zimmerman

the following described Real Estate, situate in the County of Sarpy and State of Nebraska to wit:

All that part of Sections 21 and 28, Township 14, Range 12, bounded and described as follows: Beginning at the corner on the west end of said section 28 and running thence east 9.00 chains, thence north 7.10 chains, more or less to the middle of the channel of Papillion Creek, then up the stream along the middle of the channel of said creek to a point due north of the place of beginning, thence south 9.0.10 chains more or less to the place of beginning containing 17.51 acres more or less subject however to the right of way for a County road now located along the south side of said premises and subject also to the right of way for a private road 16 ft wide along the section line between Sections 21 and 28 through said premises.
