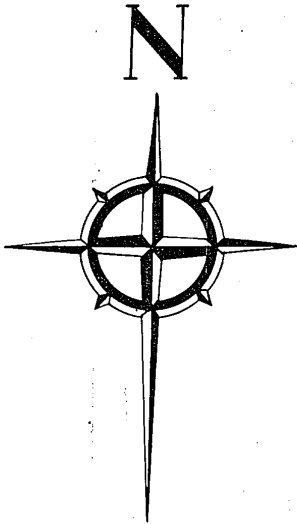

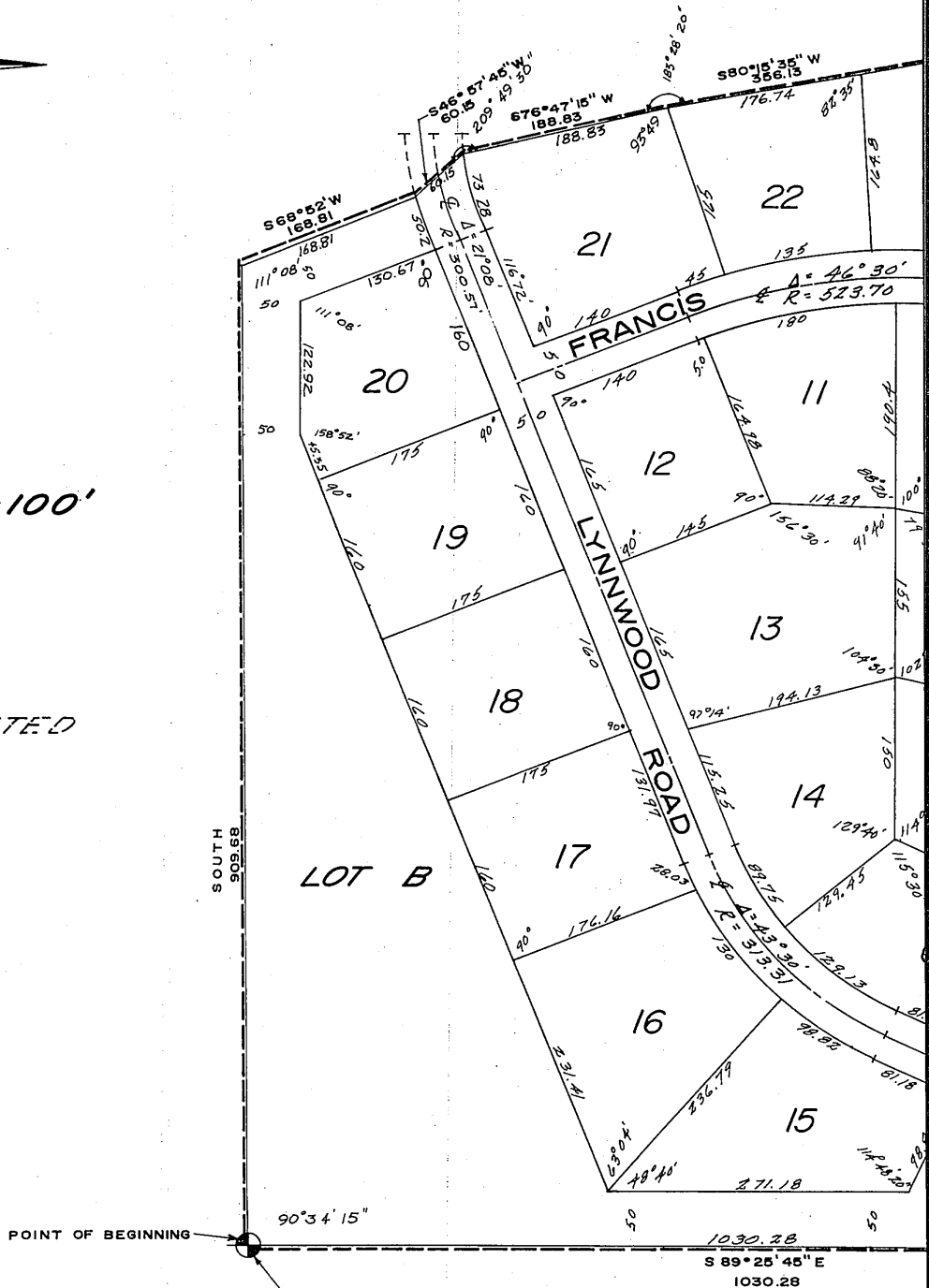
LOTS 1 THRU 27 INCL

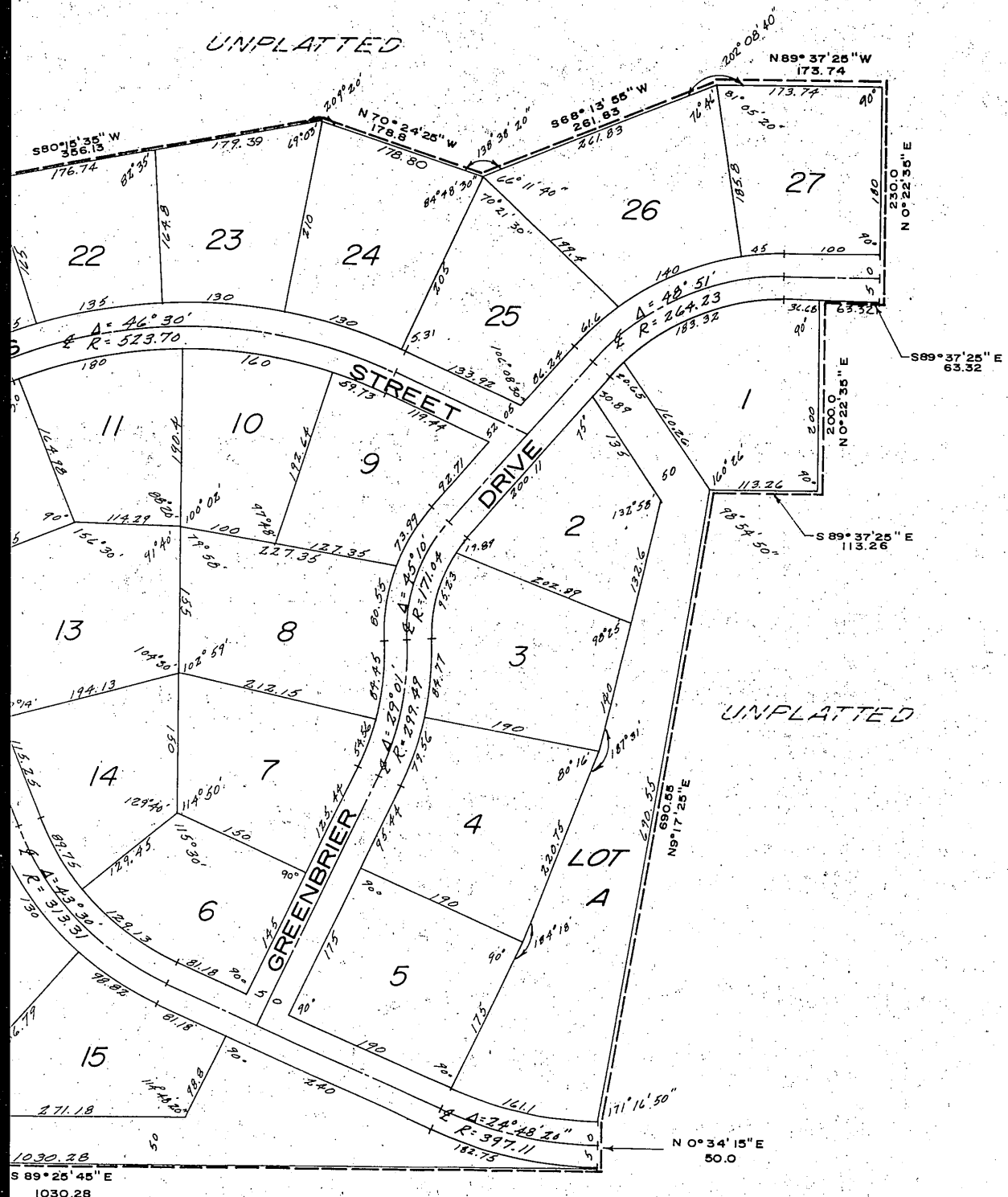
